<p>MO - By breaking the rear window to the victim's unoccupied residence to gain entry into the house and then steal the copper piping in the basement.</p> <p>On 5/26/08 at 1353hrs, officers were detailed to 1574 Warren Rd on the report from (VIC) VASILE KATSAROS that the copper piping was missing from his basement.</p> <p>Upon my arrival, I observed the residence is a vacant double home. In speaking with KATSAROS, I learned the following: He has owned the house for ten years and the house has been vacant for approximately one and a half months. KATSAROS stated he was at the property two weeks ago, everything was in order, and he locked the house when he left. When KATSAROS returned to the house today, he discovered the backyard window (on the west side of the house) was broken with a garden edge stone and the side door (on the south side of the house) was closed but unlocked. KATSAROS stated he then discovered some of the copper pipes in the basement were stolen.</p> <p>Inv Geary responded to photograph and process the scene. Nothing of evidentiary was found. I observed a decorative garden edge stone was used to break the northwest bedroom window to gain access to the house. The suspect(s) then cut the copper pipes from the basement and likely exited the house through the south side door. Nothing else appears to be disturbed in the rest of the house.</p> <p>KATSAROS desires prosecution for the crime. He does not have any suspects and was advised of the solvability factors of the crime.</p> <p>I tried to contact the residents at 1573, 1575, 1579, and 1580 Warren Rd but there was no answer. I spoke to Ljubisa Mitrovic at 1572 Warren (obt) but he did not notice anything peculiar. I spoke with (OIV) JEANNIE SOURS, and she stated that she observed the indexed vehicle pull into the driveway of 1574 Warren on 5/25/08 at 1700hrs. SOURS stated she thought it was possibly new tenants and did not watch further. The only additional information SOURS could offer about the vehicle is that she believes it may have been a 2000 or 2001 model year.</p>
