	MO1: By prying a fenced covered window, by unknown means, and attempting to gain entry into an occupied apartment building without the owners permission.
	MO2: By running from the police in an attempt to avoid arrest after committing a crime, after being instructed by officers to stop.
<p>On 05/27/08 at 1901 hrs., officers were detailed to the area of 1412 Ridgewood Ave. on the report that four black males were attempting to open a window to an apartment building. Three of the males were wearing black sweatshirts and one of the males had on a light blue sweatshirt. One of the males had on long pants and three had jean shorts on. INV FIORITTO arrived on scene first and advised that the four males were running from him, westbound through yards, going toward Lakewood Ave. When INV FIORITTO was running toward the rear of the building, he heard someone running on the steps of the rear of the building.</p>

I responded to Lakewood Ave. to intercept the males, but only one of them exited the driveway at 1435 Lakewood Ave. The male, identified as (ARJ) _____, was quickly secured in handcuffs and placed in the back of patrol car #206. While checking the area for the remaining males, an unknown resident directed officers back east toward Ridgewood Ave., stating that the males were last seen running in that direction. I then located the listed black hooded sweatshirt and doorag lying on the south side of 1453 Lakewood Ave. Officers responded on foot through the yards to Ridgewood Ave. to look for the suspect. Due to the large number of curious children in the area, I confiscated the sweatshirt and doorag and placed them in the trunk of patrol car #207. While I was responding to Ridgewood Ave., INV FIORITTO advised that the listed Plymouth Neon was seen in the area, possibly with the remaining suspects in it, last seen south on Ridgewood. PTL REBRACCA had custody of a male, identified as (ARA)JERRY MONROE, in the area of 1442 Ridgewood Ave.

While officers were speaking to MONROE, (WIT)TRANG NGUYEN, flagged me down and advised that the vehicle that officers were looking for was on Ridgewood Ave. at Detroit Ave. I radioed the location of the vehicle, and officers responded. INV FIORITTO and INV ALLEN stopped the car on Detroit Ave. at Cove Ave. The occupants, (ARA)JAMEL JONES, (OIV) _____, (OIV) _____, and (OIV)JASON MOREHOUSE were removed from the vehicle and secured in handcuffs. I spoke to JONES, as PTL GREEAR, INV ALLEN, INV FIORITTO, and INV KIRKWOOD spoke to _____, and MOREHOUSE. JONES said that he was here in Lakewood to visit a friend that he only knows as "David" who lives on Detroit Ave. He said he was walking with David to David's house, and was getting a ride from David's friend to the bus stop. JONES said he has never seen anyone in the car before, but because he was a friend of David's, they were giving him a ride to the bus stop. JONES could not explain that if he was walking to David's residence on Detroit Ave., why he was on Ridgewood Ave., or where David was.

PTL GREEAR, INV ALLEN, and DET KIRKWOOD were told that the male wearing the light blue sweatshirt was (SUS) _____, and that he was dropped off near the corner of Ridgewood Ave. and Franklin Ave. just prior to them being stopped on Detroit Ave. Officers were told by the occupants of the car that three males ran from the back yard and onto the front porch of 1430 Ridgewood. The three males were told that they could not stay there, so two of the males, JONES and _____, entered the vehicle. The third male, MONROE, did not. When MONROE was stopped by the neighbor, the vehicle left the area to drop _____ off at Franklin Blvd. _____ and MOREHOUSE identified the male with the light blue sweatshirt as their friend, _____, but they claim to not know JONES. _____, and MOREHOUSE were at _____'s house to pick him up when JONES and _____ got into the car and requested to be taken out of the area. _____ and MOREHOUSE were all released on scene.

INV FIORITTO later advised that PICKETT stated that after he witnessed the four males trying to get into the building, two males, one being the male wearing the light blue sweatshirt, was seen getting into the listed Plymouth just prior to leaving south on Ridgewood Ave. After officers stopped the vehicle on Detroit Ave., the second male, JONES, was still in the car, but the male with the light blue sweatshirt was gone. PICKETT could identify the males by the clothing they were wearing, but did not get close enough to see their faces. PICKETT stated that he did not see any of the males enter the building through the window.

INV FIORITTO responded back to 1416 Ridgewood, and found that the third window from the rear

of the building had the fence pulled from the frame and the window was unlocked. The rear of the building was checked and the north basement door was found to be unlocked. INV FIORITTO took photos of the damage and was able to obtain one latent print from the window. (OWN)ROY LEGG was contacted by another resident of the apartments and advised of the incident.

I spoke to TRANG and her husband (WIT)THIEN NGUYEN who stated that when THIEN arrived home, he stopped a male, MONROE, in the front of their home. He asked if he was in trouble and if he was being chased by the police. MONROE mumbled yes, then turned to the Plymouth traveling south on Ridgewood. The vehicle came to a slow crawl, almost stopping, as MONROE made suspicious eye contact with the occupants of the vehicle. TRANG noticed four people in the back of the car and two in the front. When officers came from between houses, the vehicle drove away. While officers were on scene talking to MONROE, the vehicle came back down Ridgewood and stopped at Detroit Ave. TRANG recognized the license plate she previously gave to officers, so she flagged me down and advised me of the vehicle's location.

JONES, MONROE, and [redacted] were arrested for Attempted Burglary and Obstructing Official Business. They were transported to LPD by PTL GREEAR, PTL ORTIZ, and PTL EIKENS, then booked in by PTL ORTIZ and CO D MCCARTHY. The listed black sweatshirt and doorag were tagged as evidence and placed in locker #8 of the property room.

MONROE has a CCH showing FBI [redacted] and BC [redacted] with priors for drugs and Possession of Criminal Tools. JONES and [redacted] do not have a CCH.
