Topic Original Report

M.O. - By pointing a silver handgun at victims and attempting to take money from the males pocket without permission.

On 5-28-08, at approximately 0005 hrs, officers were detailed to the area of McDonald's at 1430 W 117 on the report of parties having just been robbed at gunpoint. Dispatch advised that the suspect was a black male wearing a white hoodie and black doo rag. Prior to officers arriving on scene, dispatch advised that the male had entered a black 4 door vehicle with tinted windows. The victims were not sure of the make of the vehicle at that time. The vehicle then left E/B on Detroit. Officers began checking the area for the suspects.

Upon speaking with VIC/ DAVID THOMPSON, COM/ SHERREE SPURLING, and VIC/ SAMANTHA WINTERS, the following was learned: THOMPSON, SPURLING, and WINTERS had just gotten off of work at McDonald's on W 117. They began walking towards Detroit through the Walgreens parking lot. When they got to Detroit, they stopped in front of American Limousine at 11723 Detroit. They were looking for WINTERS' boyfriend, who was supposed to meet them there. When they did not see him, THOMPSON rode his bike around Walgreens to see if he could find WINTERS' boyfriend. When THOMPSON returned to SPURLING and WINTERS' location, he was approached by a black male wearing a zip up white hoodie, black doo rag and jeans.

When the male approached THOMPSON, he pointed a silver handgun at his neck and said "What do you have in your pockets? Give me your money." THOMPSON said, "no" and the male hit him on top of the head with the gun. The male then reached into THOMPSON's pants pocket and was trying to take his money, however, he was not able to get anything from THOMPSON. At that time, THOMPSON asked WINTERS for help and she came over and pushed the male away from THOMPSON.

The male then turned on WINTERS and pointed the gun at her stomach. The male then ran to a black vehicle with tinted windows, which was parked near W 117 on Detroit. The male jumped into the back seat of the vehicle and then the vehicle drove off E/B on Detroit. SPURLING stated that it was a 4 door vehicle and another black male was driving it. She was unable to give any other description of the driver, however.

THOMPSON stated he had no idea where the male came from, and does not think he would be able to recognize the male again if he saw him. He denied medical attention and did not appear to have any injuries. THOMPSON did provide a written statement of the incident and desires prosecution should any suspects be located.

SPURLING stated she would definitely be able to recognize the male again if she were to see him. She said the male walked right past her as he approached THOMPSON, but she did not see where he came from either. Both SPURLING and WINTERS stated that the male did not say anything to either of them and only pointed the gun at WINTERS after she pushed him away from THOMPSON. WINTERS also said she would possibly recognize the male again if she saw him. No further description of the males or the vehicle was able to be given by THOMPSON, SPURLING, or WINTERS at that time.
