Topic Original Report

Sgt. Eschweiler Sir:

1 On 5/29/08, at approx 2115 hrs, I was sent to the front counter of the police station to speak to a female who was assaulted on 5/28/08. The female wished to remain anonymous at this point and will be referred to as JANE DOE.

DOE said that she was at Merry Arts bar on Detroit on 5/28/08 at approx 1730 hrs. DOE said that she went there for dinner, prior to going to work. DOE said that the menu item she wanted was not available, so she left. DOE said that she only consumed 1 pop while there. DOE said that she had met a male friend there for dinner. She refused to identify him.

DOE said that at approx 1800hrs they left the bar. DOE said that they left through the front door. The friend left on foot W/B on Detroit and she left E/B on Detroit. DOE said that she was parked on Lakeland, south of Detroit, along the east curb. DOE said that she walked S/B on Lakeland, on the west sidewalk, and did not cross the street until she got to the municipal parking lot.

DOE said that she observed the listed SUBJECT walking N/B on Lakeland on the east sidewalk. She said that she crossed the street at an angle and went to her car. She began to open her door when the SUBJECT came up behind her. DOE said that the SUBJECT told that he had a gun and to come with him. DOE turned around and saw what she believed to be a gun in his hand and complied with his order.

DOE said that she was led to a grassy area between Lakewood Luthern School, 1419 Lakeland, and the first house south of the school, 1427 Lakeland. DOE said that the SUBJECT told her to "take off the pants bitch". DOE complied and asked him not to "do this" and "not to hurt her". DOE said that the SUBJECT raped her on the grass between the school and 1427 Lakeland. DOE said that the SUBJECT got up and then left. DOE said that she does not remember everything and said it felt like the entire incident took less than a minute. DOE is not sure if the SUBJECT had a condom on or not and is not sure if he ejaculated. DOE said that she pulled up her pants and then went home.

DOE said that she showered and went to her daughter's house. She has only confided in her daughter and her friend about this situation. DOE did not identify the daughter to me. The friend is OIV/ . DOE said that is a rape crisis counselor and urged her to file a report about this incident.

DOE said that the clothing she was wearing during the incident is currently at her daughter's house and that she would bring it to me later in the shift. I responded to 1419 Lakeland. The area described by DOE is between the rear of Lakewood Luthern School and 1427 Lakeland and 1426 Arthur. I checked the area for anything of evidentiary value and located nothing. The area by 1427 Lakeland is grassy. There are a couple of areas that have higher privacy fences where the incident could have been committed without being seen from either street.

I spoke to the residents at 1426 Arthur and 1426 Lakeland, who would have been home. They saw and heard nothing suspicious. There was no answer at 1422 Lakeland, which is directly across from the crime scene. At 1427 Lakeland the male was home and heard nothing. This male also owns the dry

cleaners at the corner of Lakeland and Detroit. He said that he walks between home and the business several times throughout the day and never saw anything suspicious.

I spoke to John Granzier, [(216) _____], the owner of Merry Arts, who said that his cameras were down and could not be viewed at this time. I spoke to the owner of Roman Fountain Pizza, William Campbell, [(216): _____], who said that he has a camera facing Lakeland.

The camera is motion sensitive and picks people up as they walk on the west sidewalk, along the east side of the building. Campbell pulled up the video between 1725 hrs and 1800 hrs. The motion camera did not pick up DOE arriving or leaving the area. It is possible that the camera times are off or DOE's estimation of the time is off. Campbell was given a description of the clothing that DOE had been wearing and will continue to check the cameras on 5/30/08 during the day.

At 2350 hrs DOE returned to the front counter carrying a bag. DOE said that this was the clothing that she was wearing during the attack. DOE said that if a Suspect was developed she would prosecute at a later time. She still wished to remain anonymous at this point though.

The clothing consisted of a blue button down surgical scrub type shirt and a pair of blue surgical scrub type pants. The shirt had grass stains on the back. The shirt, pants and plastic bag were all confiscated, tagged and secured in evidence locker #23.

After being at the site of the attack I asked DOE where this incident specifically occurred. DOE said that she was between the school building, east of the playground, and a house with a fence, 1427 Lakeland.

_____ said that she has spoken to DOE about the incident. _____ relayed similar information to me that did not vary from DOE told me.
