

Topic Original Report

Sgt. WYNALEK Sir;

Dispatched to Corky's on the report of a Cuyahoga County Prosecutor having problems with a family member of someone he recently sent to jail. On arrival, Ptl. HILFIKER and I were greeted outside by COM/MARC BULLARD, who advised the following:

Approximately one month ago, he was the prosecutor in a case against OIV/ARTEZ FLOWERS. During the course of the trial, BULLARD cross-examined several members of ARTEZ'S family. As a result of the trial, ARTEZ was found guilty of Robbery and various other charges and sentenced to seven years in prison.

BULLARD said that one of ARTEZ'S family members that was in the courtroom was SUB/ANTHONY FLOWERS. BULLARD said that ANTHONY was irate when he heard the verdict against ARTEZ, and that ANTHONY made several comments about it being BULLARD'S fault that his Brother was going to jail. BULLARD said that ANTHONY was verbally abusive towards him at this time.

Today, BULLARD was trying to kill some time while his car was repaired, so he decided to go to Corky's. While standing outside of the entrance, a male that he thought was ANTHONY rode by E/B on a bicycle. BULLARD said the male stared at him as he rode past, and BULLARD went inside to the bar. Shortly after sitting down, the male came into the bar and sat directly next to BULLARD even though there were several open seats available.

BULLARD recognized the male as being ANTHONY. When ANTHONY sat down, he slapped his hand on the bar and began to stare at BULLARD. BULLARD said he asked ANTHONY how he was doing, to which ANTHONY replied "Fuck You". BULLARD said that ANTHONY continued to stare at him, and he began to feel uncomfortable, so he went outside.

BULLARD tried to call a couple friends who live in the area to come and pick him up, but could not get a hold of anyone. ANTHONY followed him outside, and was talking on his cell phone at that time. BULLARD overheard ANTHONY say "I'm at the bar with that guy from court". BULLARD then phoned Det. GUZIK, who called into Dispatch to have them send Officers to the bar.

BULLARD said he waited outside, while ANTHONY went back inside. When Officers went inside to check for ANTHONY, he was gone. Ptl. HILFIKER and I checked the area for ANTHONY with negative results. I pulled up a BMV image of ANTHONY in the patrol car, and BULLARD confirmed that it was ANTHONY at the bar with him.

BULLARD said that he felt intimidated by ANTHONY and feared for his personal safety. BULLARD said that ANTHONY is known to sell drugs and BULLARD believes that he usually carries a firearm. BULLARD does not desire prosecution at this time. Officers remained on scene until BULLARD was able to retrieve his personal vehicle and leave the area. He was advised to contact LPD directly should another incident like this occur. ANTHONY has a CCH that includes multiple drug related offenses.
