Topic Original Report

M.O.: By breaking the wooden board on the door, to gain entry to the business, and taking a safe containing \$50, a birth certificate, and social security card.

On 6/3/08, at 1956 Hrs., I responded to 11829 Detroit regarding a business that was broken into over the weekend. When I arrived on scene I spoke with VIC/JANINE WEESE and learned the following:

The front door to the business was broken approximately two months ago, but was never reported. WEESE boarded up the front door at that time. WEESE indicated she has been in the process of moving her belongings out of the store. Her friend, OIV/DANIELLE GIBBS, has been helping. GIBBS spent the evening at the store, on Friday 5/30/08, with her boyfriend Chris. WEESE believes they left the store around 1300 Hrs on 5/31/08. On 6/2/08, at approximately 2300 Hrs, GIBBS came to her residence and told her the wooden board on the front of the business had been broken out. WEESE stated she was unable to respond to the business at this time but contacted the police and requested special attention the area.

When WEESE arrived at the business today, she found some of boxes containing her belongs were tossed around the room, and her safe was stolen. The safe was stored underneath an island located along the west wall of the business. The safe contained a social security card, birth certificate and approximately \$50 in loose coin.

The door had several pieces of wood attached to the frame, which was used secure the door after the glass had been broken. A piece of plywood along the bottom half of the door was broken and lying on the store floor.

WEESE stated she doesn't believe GIBBS was involved, and is has no suspects. WEESE desires prosecution. Inv. Deucher arrived to process the scene. He took photos, and found nothing of evidentiary value.
