Topic Original Report

MO: By entering into the victims locked home and removing a laptop computer and portable DVD player without the knowledge or consent of the victim.

LT. SPRAGUE SIR:

Detailed to 2112 Wascana Ave. on a report of a home broken into and a laptop computer and DVD player missing. On arrival, I was met by VIC/MARYANN L. GIMMELLI and her son, OIV/

advised that he was the last one to leave the house today at approximately 0900 hours. He is certain that he closed and locked all windows and doors when he left the house. He returned home at approximately 1430 hours and noticed that the family phone was knocked over onto the floor and his mothers laptop computer was missing. The front and rear doors, as well as all windows, were still locked. He then called his mother to see if she had taken it to work with her. After consulting with MARYANN, he learned that the computer should be at the residence and that he should call this department. He then noticed that a portable DVD player was missing from on top of the television.

MARYANN advised that she has been having problems with an ex-boyfriend who she had lived with in the past. She and SUS/ROBERT C. PORTER II had dated for years and lived together. They broke off their relationship over one year ago and MARYANN moved into her current address on Wascana Ave. PORTER never lived at the Wascana Ave. address. She has no idea exactly where PORTER currently lives. She makes no attempt to speak or have any contact with him. She advised that while they lived together, they purchased a car together and had it titled in both their names. MARYANN advised that on 12-9-07, she called this department to report that PORTER had taken that car. She believes that since the registration for that car is about to expire, he came to the home looking for the title to the car so he can take it to the BMV and obtain proper registration in his name only. MARYANN still has the title to the car. She thinks that since he was not able to locate the title to the car, he decided to take the laptop computer and portable DVD player instead.

MARYANN also advised that she has been receiving numerous hang-up phone calls recently. She has suspected that PORTER has been calling the house to determine if anyone is home. Nothing is ever said when these calls are answered. She said they always show "blocked call" or "unknown caller" on her Caller ID box. In checking her phone, there was one call received from "unknown caller" on this date at 1135 hours. MARYANN suspects that PORTER placed that call, learned that nobody was home, and then arrived and took the computer and DVD player.

MARYANN suspects that PORTER has a copy of the house keys as well. She believes that he stole them during an argument the two had last year. He has denied ever taking the keys in the past. MARYANN has also talked to her landlord regarding changing the locks but she has been unsuccessful in getting him to do that.

The Gateway computer was sitting on a wooden desk in the living room at the front of the house. It was plugged into a long white extension cord that was plugged into a wall outlet. The portable DVD player was sitting on top of the family television. INV. CRUMLEY arrived for ET work. He was able to locate some latent fingerprints. See his ET sheet for additional information.

MARYANN was able to locate the original box that the laptop computer came in. On the side of the box was the model number and the serial number. DISP. GRAHAM was able to enter the laptop into the computer.
