

Topic Original Report

M.O. By taking \$100 from VIC's hands. While VIC was attempting to get money back, SUS pulled away from VIC in his vehicle causing the VIC to fall in the street.

On 6-4-08 at 1024 hours, VIC/JOEL KODY came to the front counter to report that \$100 was taken from him. KODY stated that on 6-4-08 at approx. 0200 hours, he met three white males who appeared to be in their early twenty's at McCarthy's. KODY advised that the males invited him to a house party somewhere in Cleveland. KODY stated that he had the males drive him to First Federal of Lakewood so that he could get some money. KODY stated that he rode in a late 80's or early 90's burgundy Cutlass Sierra and was seated in the rear on the passenger side. KODY advised that they pulled up to the drive up ATM and that he reached over the back seat passenger to retrieve the money from the ATM. KODY advised that one of the males grabbed the money and kicked him out of the car in the area of Cook and Detroit. KODY stated that they then came back like they wanted to talk. He leaned into the vehicle to get his money back and the males drove away causing him to fall.

KODY indicated that he did not know any of the males in the vehicle. He could not provide a further description and stated he would be able to identify the males if he sees them again. KODY stated that he did not call LPD because he did not think there was anything that could be done. He advised that he was drinking and not thinking clearly. He stated that he attempted to call First Federal of Lakewood to see if he could cancel the transaction. I advised him that the bank probably will not reimburse him due to him withdrawing it voluntarily. KODY indicated that he desires prosecution. He was advised of the low solvability.

I observed that KODY had a large abrasion to the right side of his face and chin which he sustained when he fell to the ground. INV.CRUMLEY took photo's of the injury. KODY indicated that he did not want medical attention. KODY provided a written statement, see it for further. I made a copy of the ATM receipt for the transaction that took place at 0242 hours on 6-4-08.

I contacted First Federal of Lakewood to obtain footage from the ATM camera. Security Director Biscotti informed me that it appeared that KODY was dropped off in front of the walk up ATM, but he could not figure out how to open the door. He advised that he then walked up to the drive-thru ATM to make the transaction. It then appears that he walks towards a larger vehicle in the parking lot. Biscotti advised that he would send the pictures to DET.Lissner. Biscotti informed me that First Federal of Lakewood received a voice message from KODY at approx. 0400 hours on 6-4-08 where he stated he was robbed. The photos contradict KODY's version of what occurred.
