Topic Original Report

MO/ By failing to stop for police officers executing a traffic stop using lights and sirens.

On 6-4-08, around 0045 hours, I was behind the indexed vehicle on Detroit at W117th. The temp tag on the vehicle looked as if it had been ripped off a vehicle and reattached. The eyelet holes in the temp tag were torn and jagged. I had dispatch run a computer check on the vehicle. The vehicle went EB on Detroit and turned SB on W112th.

The listing came back and it showed the listed owner, SUS/GAUGHAN, had a suspended license and active warrant out of CCSO for Drug Trafficking. The driver was a match for the listed owner in height, age and race. I attempted to catch up to the vehicle. The vehicle was moving at a high rate of speed and seemed to be trying to distance itself from me. The vehicle turned EB on Madison and I started to catch up to it at Berea/Madison. The vehicle turned SB on W105th and was moving at a high rate of speed. I activated my lights and the vehicle seemed to speed up. I hit my siren and the vehicle began to slow down. The vehicle looked like it was going to stop then it pulled into the driveway at 2067 W105th. The driver was the only person in the vehicle. He jumped out of the vehicle and ran EB through the yards.

The driver was wearing a red knit hat and a tan overcoat. I chased him EB and lost him on W104th. Units responded to the area and the male was not located. I looked at the BMV photo of GAUGHAN. He was a match for the driver of the vehicle.

The vehicle was towed Kufners where it will be held for OWN/LIC driver/Detective Bureau. A video request was completed for my cruiser's in car video. In checking the video you are unable to see the driver when he exits the vehicle.

GAUGHAN's CCH shows an FBI number of [REDACTED] and a BCI number of [REDACTED]
