Topic

- MO: 1. By being on the property of a vacant house without permission to be there.
 2. By providing a false name, date of birth, address, phone number to conceal their true identity.
 3. By being under the age of 18 yrs and in possession of cigarettes.
 4. By being in possession of a glass pipe with burnt residue, commonly used to smoke marijuana.
 5. By being in possession of a baggie of marijuana.

6-6-08, Ofc. Piechowiak and I were detailed to one house north of 1663 Bunts on report that three juvenile females were in the back yard doing drugs. I arrived first and found the address to be 1661 Bunts. Upon entering the back yard, three juvenile females were found sitting on the deck of a vacant house. I observed ARJ/ holding a yellow glass drug pipe and a baggie and when she saw me she attempted to conceal it. These items were immediately confiscated and the baggie was found to contain marijuana. ARJ/ was sitting next to and had her purse open and laying on the side. I observed, in plain view, a pack of Marlboro Milds 100's cigarettes in her purse which were also confiscated. ARJ/ was also present and sitting next to

All three advised that they did not have permission to be at the house. stated that her family used to own the house but has since sold it. MIN information was gathered on all three parties as follows:

provided her information as MELISSA A. JOHNSON, Westwood, 216- , DOB: 8-20-1992, Father:

provided her information as JESSICA S. RUNT, Lakeland, 216- , DOB: 12-13-1991, Mother: Alyssa, Father:

provided her information as ASHLEY (NMI) RENEE, Winton, 216- , DOB: 2-10-1992, Father:

I had dispatch contact LHS, were each stated that they attended. School personnel advised that they did not have students by those names. The three were confronted with the fact that the school did not have students by that name. and decided to provide there correct information but still gave false phone numbers. School personnel provided the correct phone numbers for them and advised that they should be at school at this time. Dispatch contacted the parents of each of the three.

Ofc. Piechowiak transported back to school at Lakewood City Academy where she was released to school personnel. I transported and to the station. was released to her father on the back hill. He provided the correct MIN information for and was advised that he would be receiving notice in the mail of a court date in juvenile court. He was advised of 's charges and he was given a copy of the citation for the possession of tobacco products by a minor.

While on the back hill, advised that she too lied about her identifying information. After she provided her correct MIN information, dispatch was able to contact a parent to respond. Due to the amount of time it was going to take someone to respond, was booked into the jail by CO. Gonzales and dispatcher, Kluiber. At the booking window, while inventorying her property, a pack of Marlboro Milds 100's cigarettes was located in her bag. This pack of cigarettes was confiscated and a

All confiscated property was later tagged and given to the property room clerk. I did speak to BROWN by phone and he wishes to prosecute for Criminal Trespass.
