

|  | <p>On 6-6-08 at 1354 hours cars were detailed to 1678 Elbur on report from COM/MARY CRAWFORD that a suspicious vehicle was parked in the drive of that home yesterday and she is afraid that they may have stolen copper piping. Upon arrival, I found a west facing rear window of the vacant home open. I entered the home through the window and found the copper piping had been stolen from the basement. All copper from the hot water tank, water meter, washer, outside faucet, and adjoining piping was gone. The pipes appeared to have been broken off and not cut cleanly.</p> <p>Other than the open rear window, the house was secured and there was no other damage.</p> <p>Upon speaking to CRAWFORD, she advised on 6-5-08 between 0930 hours and 1650 hours she observed the listed Chevrolet truck parked in the drive. The truck had a white trailer attached that was left in the drive several times when the truck left for several minutes and would then return. CRAWFORD thought the truck was suspicious and wrote down the plate but did not call police until today.</p> <p>Inv. Kulczycki responded to the scene and found NOV. See his photo sheet for additional information.</p> <p>The truck lists to OIV/JAMES ROMERO. Using the Cuyahoga County Auditors web site, OWN/BRUCE MOHLINE was found to be the owner of the home.</p> <p>Multiple phone messages were left for MOHLINE at his home and office and I received one message advised that ROMERO was an employee of his. Several more messages were left for MOHLINE regarding the theft of the copper and if he desired prosecution but none of the calls were returned.</p> |                 |
