**Topic**

- MO: By being in possession of suspected heroin.
- By being in possession of an unknown prescription medication that was prescribed to another.
- By being in possession of an unknown prescription medication in a container other than a prescription bottle.
- By being in possession of an unlabeled prescription bottle containing unknown prescription medications.
- By being in possession of items commonly used in the aid of injection of drugs of abuse.
- By being voluntarily intoxicated and a risk of harm to herself and/ or others.

6-8-08, Ofc. Robinson and I were detailed to the area of the City Center on report that a juvenile male called stating that a w/f with blonde hair and wearing white pants and a brown shirt, tried to sell someone Oxycotin. Two males stole her Oxycotin and left and the female then accused the juveniles of stealing her Oxycotin and tried to hit them. The female was walking e/b on Detroit and the juveniles were following her as they spoke to the police.

Ofc. Robinson and I believed that the female could be ARA/ ANGELA HEDGES who lives with her mother at 14401 Detroit. Ofc. Pietch advised us that he had dealt with her earlier when her boyfriend was arrested at Marc's for possession of hypodermic needles (see rept 08-004724). As we were arriving on scene, dispatch advised that the female went into the building at 14401 Detroit.

Ofc. Robinson and I located HEDGES in the lobby of the building, attempting to get into the security door. She is known to this department as one who abuses drugs. She was unsteady on her feet and her eyes were half closed. It was believed that she was under the influence of drugs of abuse and a risk of harm to herself. She was placed under arrest for intoxication and kept trying to squirm away while being handcuffed. A search of her person revealed two bundles of suspected heroin that were tied together in her front, right pants pocket. She was advised of the additional charge of possession of heroin and she stated that she was just holding for Scott. Scott is MICHAEL SCOTT HOOK who was arrested earlier by Ofc. Pietch.

I took possession of HEDGES' property including the suspected heroin while Ofc Robinson transported her to the station and booked her in with Ofc Forristell and dispatcher Sykora. During this time I spoke to the group of juveniles involved. They were identified as COM/ , OIV/ , OIV/ , OIV/ and OIV/ . They advised that they were all sitting on the benches at the City Center Park when HEDGES walked over near them and sat in the mulch of the flower beds. She kept falling over and then asked four 17-18 year old males to come over to her. The males all had red bandanas and when they walked over to her she told them that she had Oxycotin and Zanax and asked if they wanted to buy any.

As Hedges opened up the bottle and poured the pills into the palm of her hand, spilling some onto the ground. One of the males picked up some of the pills and they walked away. HEDGES walked over to and and accused them of stealing her "Oxy" and her money. They told her that they did not take anything and she told them that they were all going to get 'yanked". She then tried to hit in the face but swung and missed. It should be noted that was wearing a red t-shirt that she may have mistaken for the red bandanas that the

other males were wearing. They stated that HEDGES got on her phone and was telling someone that these males stole her "Oxy". She was then describing \_\_\_\_\_ to whoever she was talking to. HEDGES started walking e/b on Detroit and the juveniles followed her and called the police on their cell phone.

Returning to the station, HEDGES bag was searched and the following items were located: purple cell phone; 90 packets of alcohol prep wipes; a blue elastic band that is the same type that is used to engorge veins while trying to draw blood or inject drugs; a prescription bottle without a label, that contained 3 white tablets; a prescription bottle issued to Eleanore Hedges of 50 mg Tramadol, containing 35, white, oval tablets (RX# \_\_\_\_\_); a prescription bottle issued to Eleanore Hedges of 1 mg REQUIP, containing 59 green octagon shaped tablets (RX# \_\_\_\_\_) and a 35mm film bottle that contained 7 round, white tablets, 1 tablet marked "Advil" and 1 yellow and orange tablet.

All of the above items were confiscated and tagged and placed into secured storage. At the station Ofc. Robinson advised that HEDGES was being transported to the hospital for her well being due to her unable to stay awake while standing up at the booking window and speaking incoherently. He advised that she had a twenty dollar bill in the same pocket as where the heroin was located. This was confiscated and tagged as evidence. It should be noted that I located a citation in HEDGES' property issued by Ofc. Harner for possession of hyperdermic needles on 6-4-08.
