Topic Original Report

MO: By forcing open the rear door of a duplex home and taking camera's and jewelry from the up and down units without the knowledge or consent from the owners.

Sgt. Eschweiler, Sir:

On 6/12/08, at 1900 hours, I was detailed to 1285 and 1283 Hathaway on a report of a burglary. On arrival I spoke to VIC/ JOHNATHON TOMASELLI and VIC/ ANASTASIA TOMASELLI and learned the following: ANASTASIA advised that JOHNATHON was the last person to leave the residence at 0845 hours this morning. ANASTASIA arrived home at 1715 hours and noticed that the rear door to the residence was broken and the door was open. She also noticed that her rear door to the down unit was open. She did not enter the residence. She stated that the up tenant arrived home around 1730 hours and noticed that her up door was damaged and open. That is when she called LPD.

I spoke to the up tenants and they were identified as VIC/ JENNIFER WAGNER and VIC/ AYMAM GHOSHEH. The following was observed: The rear door to the home had the top window broken in. It appears that someone reached inside the door to unlock the dead bolt. Someone entered the back stairwell and went to the up unit first. The up unit door was broken. It appears as if someone used their shoulder to knock out the top portion of the wood panel door. They reached inside and unlocked the door. They went into the north/east bedroom and took jewelry from a jewelry box off of the dresser on the west wall. Taken was a pair of 3/4 kt gold diamond earrings, 1 kt gold diamond pendant, a pink satfire 2 kt white gold ring, and a 1/2 kt purple stone white gold ring. Also taken off of the dresser was a silver Sony digital camera. WAGNER did not know the model or serial number for the camera. Someone then entered the north bedroom and took two books of GHOSHEH's checks. The checks were from Fifth Third bank. He did not know the series numbers of the check, but he already contacted his bank and put a hold on his checking account. Nothing further was taken.

Someone then exited the up tenants front door and went down the front stairwell. Someone broke the window pain of the down tenants door. They reached inside and unlocked the door. Someone took a Canon digital camera off of the dining room table. The camera is a Canon SD450 with 5.0 Mega Pixels. JOHNATHON TOMASELLI did not have a serial number for the camera. Someone then entered the north/east computer room and took various necklaces off of the dresser. ANASTASIA TOMASELLI advised that the necklaces were just costume jewelry and she could not describe the necklaces and did not know how many were taken. Also taken off of the dresser was about fifty dollars in various denominations of US coin. The coins were in a glass jar that was left behind on the dresser. Nothing further was taken. It appears that whoever entered the home then exited out the rear door that was initially broken.

JOHNATHON advised that he found a black comb on the floor next to his bed. It was on the south side of the bed. He advised that it was not his comb and his could not recall seeing it before. The comb was left on the floor to be photographed and collected as evidence by INV DEUCHER. None of the residents had any suspects. They were all advised of the solvability factors.

I canvassed the neighborhood. There was no answer at 1281, 1300 and 1302. The resident of 1279 advised that he was at work all day and did not see or hear anything. I spoke to the resident of 1280 Hathaway and he was identified as OIV/ MICHAEL RYAN. He stated that he was home all day and the only thing he observed was a Rent-A-Center truck parked in front of 1305. He stated that he believed the truck was parked there between 1400 hours and 1700 hours. He saw the truck leave with two black males inside. He could not describe the males.

At the station, I contacted the Rent-A-Center on Lorain Road. The male that I spoke to advised that a delivery was made at 1430 hours to 1297 Hathaway. He did not give me the name of the resident.

INV DEUCHER advised that latents were found.
