N A R R A T I V E 1	<p>Topic Original Report</p> <p>M.O. By being in possession of four speakers and two amplifiers that were entered into LEADS as stolen</p> <p>M.O. By being in possession of .91g of marijuana</p> <p>M.O. By being over the age of eighteen and smoking marijuana with a juvenile under the age of eighteen</p> <p>On 6-12-08 at 1609 hours I observed the listed 1991 Pontiac Grand Am traveling w/b on Detroit at Edwards. The owner, ARA/ANDREW WALLS, was a named suspect in a felony theft report I took on 6-7-08. In that report, over \$2900.00 worth of stereo equipment was stolen from OWN/DEREK SINDYLA. See original report number 08-004691 for additional information.</p> <p>I observed the vehicle go left of center on Detroit at Bonnieview prior to turning left into Johnny Malloy's parking lot. I activated my overhead lights as the vehicle pulled into the parking lot and the vehicle parked behind the restaurant. As I approached the vehicle, I observed the front male passenger, later identified as ARJ/ , attempting to hide something in between the front passenger seat and the center console. The driver was identified as WALLS.</p> <p>There was an immediate smell of burnt marijuana coming from the inside of the vehicle. Initially, WALLS said that he was smoking marijuana earlier and that the smell was from him. Ptl. Thibodeaux, Ptl. Obrock, and Inv. Malloy arrived on scene to assist.</p> <p>Ptl. Thibodeaux removed from the vehicle and I removed WALLS. WALLS advised that officers could check his vehicle because he knew there was no marijuana left in his car. The listed marijuana cigarette was located in between the front passenger seat and the center console. The</p>

listed cigar was located on the front passenger seat where _____ was sitting. Both males were advised they were under arrest for M-Drug Abuse at this time. WALLS was also advised he was under arrest for Contributing to the Delinquency of a Minor. _____ was placed in car 205 and WALLS was placed in car 207.

Upon searching the vehicle, the listed 10" O2 speakers were located in the back seat, the Hifonics 3200 Watt amplifier and 2 Kicker Subwoofers were located in the trunk. The Hifonics amplifier was confirmed as being entered as stolen through LEADS by our department. The two 10" O2 speakers were also identified as the speakers stolen from report #08-004691 along with the amplifier.

Both WALLS and _____ were advised that they were now also under arrest for Felony-RSP. _____ was additionally charged with Underage Possession of Tobacco Products, and Seatbelt. WALLS was advised he has the additional charge of Left of Center. WALLS was advised of his Miranda Rights by this officer.

WALLS initially stated that he knew the stereo equipment was stolen, but stated he bought them from a black male named "D". _____ was not questioned.

Inv. Malloy took photographs of the property, confiscated, tagged, and placed them all in the property room. The vehicle was towed to Kufner Towing.

Ptl. Thibodeaux transported _____ to the station where he was booked in by C.O. McCarthy for F-RSP, M-Drug Abuse, Underage Possession of Tobacco Products, and Seatbelt. _____ was issued traffic citation #D162148 for Underage Possession of Tobacco Products and Seatbelt. _____ was provided a copy of the citation.

As I was transporting WALLS back to the station, he started crying and said he would answer questions regarding the stolen stereo equipment. In speaking to WALLS, he told me that on the night of 6-7-08 he was walking west end streets looking for unlocked cars doors and items to steal from those vehicles. While on Roycroft, he found the drivers door of the vehicle belonging to SINDYLA unlocked. WALLS advised that he knew SINDYLA had a large amount of stereo equipment in his vehicle so he went to get his vehicle and returned to ROYCROFT to steal the stereo equipment.

WALLS advised he was alone and took four speakers and three amplifiers from SINDYLA'S vehicle. WALLS did say that one of the amplifiers sparked when he was removing it from the vehicle, so he just threw that amplifier away. WALLS then took the equipment and put it in his garage at home until he installed some of the equipment in his own car..

WALLS agreed to sign a consent to search his home. WALLS was transported by this officer and assisted by Inv. Malloy and Ptl. Pietch to his residence at 1588 Olivewood. WALLS advised the other two speakers and amplifier were in the garage. Those items were located toward the rear of the detached garage. Inv. Malloy photographed the items, confiscated them, tagged them, and placed them in the property room.

WALLS was then transported back to LPD by this officer. A inventory of property seized during a consent search form was completed and signed by WALLS, Inv. Malloy, and this officer. WALLS was booked in by C.O. McCarthy for F-RSP, M-Drug Abuse, Contributing to the Delinquency of a Minor, and
