Topic Original Report

M.O. By entering an unlocked living room window to gain entry into the vacant residence, using the listed pruning shears to cut copper pipe in the basement, taking a circular saw, nail gun, and a staple gun, and then leave the home with same and without the victim's consent.

On 06/12/08, at 2031 hours, I was detailed to 1507 Elmwood on a call from VIC/MURIL DAVIS JR. He advised that his house was broken into and copper piping was stolen. Upon arrival, I learned the following:

DAVIS JR. recently purchased the residence and is in the process of renovating the property. He advised that he left the residence, at approximately 2100 hours, on 06/12/08. DAVIS JR returned at 1830 hours on 06/13/08. When he arrived at the house, he noticed that the northernmost window from the first floor living room was removed, and placed in front of the fireplace. DAVIS JR placed the window back into place prior to our arrival. He advised the front and rear patio door to the residence were locked. While placing the window back into place, DAVIS JR noticed a footprint on the floor that he did not recognize. The print was of a smaller foot with possible Converse tennis shoe markings. INV PICKENS took photos of the footprint.

In checking the exterior, there were no signs of forced entry to the residence. DAVIS JR cannot recall if the side door was locked when he arrived at the residence today. He advised that the front windows were not locked.

DAVIS JR went downstairs into the basement. The basement is accessed directly off of the side door on the south side of the house. He observed pruning shears, with wood and blue handles on the floor, at the bottom of the stairs. DAVIS JR advised that this tool was not in the home when he left the night before. He continued into the basement and saw that all of his copper piping was missing. DAVIS JR recently removed the old piping when he purchased the home. He advised that it was placed in a pile on the basement floor. DAVIS JR recently replaced all of the piping. There was very little water on the basement floor, and it appeared as if the water was shut off before the pipes were cut. The copper pipes were cut from the main line, from the hot water tank and from the furnace. There were two small pieces left behind on the floor. In total, about 300 ft. of copper piping had been removed.

DAVIS JR continued to check the house. He found that the listed staple gun, circular saw, and nail gun were taken from the bedroom on the second floor. The bedroom is on the south side in the front of the house. DAVIS JR could not provide the make or model for the equipment. He was only able to remember that they were purchased at Home Depot.

INV PICKENS took photos and attempted latents but with negative results. The pruning shears were confiscated, tagged, and placed in the property room.

I was unable to speak with immediate neighbors regarding the incident. DAVIS JR does not have any suspects at this time. He desires prosecution.
