N A R R A T I V E 1	Topic Original Report	
<p>On 06/14/2008, at 1910 hours, Ptl. Greear and I were detailed to 1632 Lincoln Avenue on a report of a theft. Upon arrival, we spoke with COM/JEFFREY PRIOLA. JEFFREY advised his 13 year old son, OIV/ [REDACTED], had given \$60.00 to SUB/ [REDACTED] to buy marijuana. However, [REDACTED] took the money [REDACTED] had given him and did not return with the money or marijuana. JEFFREY stated he did not want to file any charges for the theft and only contacted LPD to attempt to speak with [REDACTED]. JEFFREY advised [REDACTED] resided at [REDACTED] Lincoln Avenue and was 16 years old. In checking [REDACTED], no money or paraphernalia was found on his person.</p> <p>Ptl. Cantlin arrived on scene and we spoke with OIV/SOPHIE SAS, the mother of [REDACTED] SAS advised Ptl. Cantlin that her son was not home at the time. SAS also stated her son had been expelled from school for drug paraphernalia but she was unaware that her son was selling and/or purchasing marijuana for the neighborhood kids.</p> <p>In further speaking with JEFFREY, he stated that [REDACTED] originally said he was robbed and his money was taken by an unknown male. After further discussion with [REDACTED], JEFFREY was able to determine that [REDACTED] had lied about the incident. At the time, [REDACTED] stated he had supposedly given his money to [REDACTED] to buy him marijuana. However, JEFFREY was still unsure that this version of the story is actually what had happened. Therefore, he only wanted us to speak with [REDACTED] and get his version of the story. We were unable to make contact with [REDACTED].</p> <p>JEFFREY stated he wanted this report on file but no other police involvement at this time. JEFFREY advised he would follow up with the juvenile courts at a later time to seek advise and further action.</p>
