NARRATIVE

Topic Original Report

M.O.: By entering a residence through an unlocked door and taking property without the owner's permission.

Sgt. Eschweiler, Sir:

On 06/17/2008, at 1908 hours, Inv. Deucher and I were detailed to 17302 Riverway Dr. on the report of a burglary. On arrival, we met VIC/GILBERT M. NEWLANDS, the owner of the residence.

NEWLANDS advised that he left the house at approximately 1540 hours on 06/17/2008. NEWLANDS returned at approximately 1805 hours, on 06/17/2008. Upon entry, he observed that the door to the east side of the house was open approximately five inches, and that a table, normally placed directly against the door, was pushed back approximately five inches. Salt and pepper shakers, normally on top of the table, were lying on the floor inside the room. NEWLANDS advised that a couple of dimes and nickles were also laying on the floor. Nothing else appeared disturbed or missing on the main level of the home.

NEWLANDS then went upstairs, and noticed that a door at the top of the steps was pushed open approximately six inches. Normally, according to NEWLANDS, that door is shut or only cracked open. When NEWLANDS entered the second bedroom on the east side of the upstairs hallway, he noticed that a ceramic bowl, approximately \$65 in assorted U.S. change stored within the bowl, as well as two antique picture frames with generic photographs, were missing. Two dimes were lying on the floor next to the dresser. Nothing further was missing or disturbed on the second floor, or anywhere else inside the house.

NEWLANDS explained that the side door is always unlocked because he lost the key a few years ago. Outside of the door is a screened patio, the door to which was locked, but can be forced open by pulling it with moderate force. NEWLANDS advised that he is getting the lock changed on 06/18/2008. NEWLANDS stated that the other doors to the house were locked when he left, and appeared to be locked when he got home.

NEWLANDS believes that SUS/ K entered the house and took the indexed items. NEWLANDS stated that he filed a prior burglary report against K on 04/05/2007. NEWLANDS explained that he met K approximately three to four years ago at Edgewater Park. K was homeless at the time, and, out of a desire to help a fellow human being, NEWLANDS invited K to move in with him. K lived at the house for approximately six months, before NEWLANDS, angered by K's drug abuse, asked K to move out. NEWLANDS advised that he was never romantically involved with K.

NEWLANDS does not believe that K has a key to the house. NEWLANDS last spoke with K approximately four months ago when the two had lunch together. NEWLANDS does not know exactly where K is living, but thought he might be somewhere in the area of 4300 Berwald Rd. in Cleveland. NEWLANDS also advised that K often stays with OIV/ S, who lives at 1211 Giel Ave.
