Topic Original Report

MO: By intentionally brandishing a firearm, causing victims to believe they were in danger of serious physical harm.

MO: By transporting an unloaded firearm under the drivers seat of his vehicle.

MO: By being voluntarily intoxicated and being involved in a fight.

On 6/17/08, at 0214 Hrs., PTL. DE MCCARTHY and I were detailed to 18616 Detroit (Around The Corner Bar) on a anonymous call of a fight. PTL. MCCARTHY arrived on scene first and several parties left the scene. Two males later identified as ARA/TYLER DRUMHELLER and ARA/JASON LAPE advised three males in the listed black Cadillac were involved in the fight. I observed the vehicle turn right onto Sloane from Detroit. I initiated a traffic stop and the vehicle stopped in front of 1353 Sloane.

I approached the vehicle and advised the driver the reason for the stop. He identified himself as ARA/ANTHONY MAYWEATHER. While speaking with MAYWEATHER dispatch advised there may have been a gun involved. PTL. MCCARTHY and PTL. MINTEER arrived at my location to assist. MAYWEATHER and his two passengers ARA/JEFFREY KAROHL and ARA/DANIEL NELSON were removed from the vehicle and secured in handcuffs. I asked MAYWEATHER about the gun and he advised it was in the car unloaded. I recovered a Glock 22 under the driver seat unloaded with the slide in the forward position. MAYWEATHER stated he did not have any magazines in the car. I checked the car further and located two empty magazines in the drivers side door. I never located any live ammunition.

PTL. MOLNAR, SGT. GANNON, and PTL. GAMPFER were speaking with DRUMHELLER and LAPE. DRUMHELLER and LAPE stated they did get into a fight with MAYWEATHER, NELSON, and KAROHL. They advised that MAYWEATHER brandished and threatened them with a gun. DRUMHELLER and LAPE alleged that they were jumped by MAYWEATHER, NELSON, and KAROHL. Both groups advised the problems between them had been a on going issue throughout the night. Dispatch also received several anonymous calls stating that a male had a gun.

I advised MAYWEATHER he was under arrest for Aggravated Menacing and advised him his Miranda rights. He stated he understood his rights. MAYWEATHER stated a group of about eight people "jumped" himself, NELSON, and KAROHL. He said he went to his car and got his gun to scare them away because he was afraid for his life. MAYWEATHER further stated it was a bad decision but he was afraid for himself and his friends.

NELSON and KAROHL both confirmed MAYWEATHER'S account of being jumped by several parties. NELSON and KAROHL both stated they knew nothing about the gun. NELSON was not intoxicated but was issued criminal citation #M40395 for DCI for his involvement in the fight. KAROHL admitted to being intoxicated and was issued criminal citation #M41254 for DCI and released to NELSON.

DRUMHELLER and LAPE were issued criminal citation #M38897 and #M41055 for their involvement in the fight. MAYWEATHER was transported to LPD and booked in by myself and PTL.
