1 N A R R A T I V E	Topic	Original Report
	<p>On 06/17/2008, while on patrol, I ran a random registration check on the listed Chevrolet which was parked unoccupied at WALGREENS. The vehicle owner, (SUB)COX, came back suspended. There was also a confiscation order for the license plates and registration from the Ohio BMV. At 0213hrs, I observed the vehicle back out of a space and prepare to leave the lot. I pulled behind the vehicle and determined that the driver appeared to match the physical description provided for COX. The vehicle was stopped on DETROIT at W116TH.</p> <p>The operator produced his Ohio OL identifying him as COX. He was informed of the reasons for the stop. COX claimed he was not aware of the suspension. He was picking up some items at WALGREENS, and thus not driving due to any emergency.</p> <p>COX was found to be under a Non-Compliance suspension 10/06/06-01/04/07 with FRA 10/06/06-10/06/09. Proof filing was canceled 05/02/08. Note that COX's insurance card was from the same company, Safe Auto, and showed dates of 04/02/08-10/02/08.</p> <p>COX was issued Citation #D162685 for DUS. He was advised of his mandatory court date. His OL was confiscated and later tagged to be sent back to the BMV. Both license plates and his vehicle registration were confiscated per the BMV order. These items were later tagged and placed in the mail to the Ohio BMV. COX was informed of the conditions for the release of his vehicle. It was towed to Kufner Towing to be held for Court Authorization.</p>
