	<p>On 6/18/08, at 0222 hrs., I was detailed to Lakewood Hospital Er, on a call from Hospital staff, advising they were treating a male who was assaulted at Lakewood park. On arrival I spoke with SUB/JACOB CZECHANSKI and he stated he got in as fight at a party. He was uncooperative stating he didn't want any police involvement. CZECHANSKI'S face was swollen and his left wrist was injured. CZECHANSKI stated he knew the people who he had the altercation with but would not tell me. He again stated he did not want LPD involvement. He was being treated by Dr. Grabin. At the time of this report the extent of CZECHANSKI'S injuries were still being evaluated.</p>
