Topic Original Report

M.O.: By punching the victim in the head and face, causing him to fall off of his bicycle causing physical harm, and trying to take the same.

On 6/18/08, at 0030 Hrs, Officer Brown and I responded to CVS, 11701 Clifton. Dispatch advised two black males attempted to steal a bicycle, but were scared off by another customer. While traveling to the scene, Dispatch indicated the male had been assaulted and had injuries, but denied medical attention. When I arrived on scene I spoke with VIC/JOSHUA HARRIS and learned the following:

HARRIS stated he and his friend, OIV/MARK NATHANIEL, were riding their bicycle's northbound on W117th. HARRIS stated while riding, an unknown black male struck him in the back of the head causing him to fall off his bicycle and scrape his left leg and knee. While on the ground, a second black male punch him in the face while the first male tried to steal his bicycle. HARRIS stated he held onto his bicycle, and was eventually able to get it back. HARRIS stated he got back on his bike and continued to ride north until he arrived at CVS. While at CVS someone contacted the police for him. HARRIS believed there to be approximately an eight minute delay.

HARRIS stated his friend NATHANIEL left the scene as soon as HARRIS was struck in the back of the head. They road their bike's from Parma to visit NATHANIEL's girlfriend. HARRIS was unsure of the female's name and is unsure where she resides.

The male who struck HARRIS in the back of the head was a bald light skinned black male, approximately 5'9", 20 years of age, and had a mustache and beard. This male was behind him most of the time, so he did not get a good look at his clothing. The second male was a dark skinned black male, approximately 5'6", 18 years of age, with dread locks. He was wearing a red shirt with dark jeans, and had facial hair.

I transported HARRIS southbound on W117th for him to identify where the incident took place. He stated it happened on the sidewalk in front of 1506. After he rode away on his bike, the males ran westbound through the bushes.

HARRIS had a split upper and lower lip on the left side, and had a scrape on his left leg. Inv. Deucher arrived on scene and took photo's of his injuries. A written statement was obtained from HARRIS, and he desires prosecution. HARRIS would be able to identify the male with dread locks, but is unsure about the bald male.
