Topic Original Report

MO. By pushing up unlocked window and screen, entering home, and taking listed purse with contents.

On 06-18-08 I was detailed to 2380 Northland Ave., on the report that a purse was taken from the home there. Upon arrival I spoke with (VIC) NOREEN SULZER who advised the following.

SULZER lives with her daughter, (VIC) AMY BOONE, who owns the home there. Sometime between the listed times SUS(s) pushed up the unlocked first floor window, entered the home, and took the listed purse. The point of entry/exit was on the south side of the home. The purse was taken from the steps that lead from the first floor to the second floor. These steps are just inside the window, but it should be noted SUS(s) would have had to enter the home to reach the purse. Both SULZER and BOONE were on the second floor sleeping at the time of the theft.

While speaking with SULZER and BOONE, (OIV) ELIZABETH LANTZ approached officers and stated that she had found a purse on her back porch. LANTZ lives one house south of SULZER and BOONE, and SULZER identified the purse as the one taken from her home. INV. GEARY photographed the purse, and it's contents before it was returned to SULZER. SULZER advised that the only thing that appears to have been taken was about \$10 in U.S. currency.

INV. GEARY then performed ET, dusting around the window that was the point of entry, but nothing of value was found. Neither SULZER or BOONE have any suspects in this incident and both desire prosecution.
