NARRATIVE

Topic Original Report

MO: By shoplifting several items, leaving the store without paying for same and then getting in a waiting car to leave the area.

Sgt. L. WILKINS;

On 06/19/08, cars were detailed to Rite Aid, located at 16207 Detroit Ave., on the report of a shoplifter. As cars were responding, dispatch advised that the suspect ran out of the store and got into a waiting car. Dispatch advised that the car was a silver colored, Mercury Sable, OH license plate #EJT 9013, and they left SB on Northland. The plate listed back to SUS/STEPHANIE M. ARTHUR. The manager of the store, OIV/DANIEL L. KNEPPER, was now supposed to be following this car. The Mercury then went EB on Madison, south on Warren and then west on I90. At this point, KNEPPER stopped following the car.

Dispatch advised that they received a call from another male who advised that he was now following this car. The caller was later identified as WIT/RAMI L. OURI. OURI kept dispatch informed of the direction this Mercury was going. Dispatch advised that they got off I90 at Hilliard. Rocky River PD was contacted and advised of the above.

RRPD Officer Bunner #31, in car 11, advised he had the suspect auto stopped at Northview and Hilliard in Rocky River. However, the male passenger got out of the car and took off running. Officer Bunner chased after this male and caught him at 2326 Northview. The driver of the car had taken off from the stop, in the suspect vehicle, in an unknown direction. Officers checked the area with negative results.

The male that Officer Bunner had apprehended was identified as, ARA/JAMES C. DODRILL. DODRILL was not cooperating as to who was driving the car and where they might be going. DODRILL was searched incident to his arrest and was then placed in the rear of my patrol car #203. DODRILL was read his Miranda Rights and he stated he understood same. I attempted to speak to DODRILL but he would not answer any questions.

Officer Bunner described the driver of the auto as a white female, with brown hair and in her early 20's. The description matched that of the listed owner of the suspect vehicle, ARTHUR.

I spoke to OURI and he related the following. OURI was on Northland when he observed a male running through the Rite Aid parking lot. OURI saw that this male was carrying a large amount of items. OURI also saw that the male was being chased by a male employee of Rite Aid. OURI advised that the car went past him and he turned around and started following the car. OURI then called LPD and gave the direction of travel of the suspect vehicle. OURI was present when Officer Bunner caught the male suspect. OURI also advised that this was the same person he had observed running through the Rite Aid parking lot.

I transported DODRILL to Rite Aid to see if KNEPPER could identify him as the shoplifter. While I

was driving there, I asked DODRILL where ARTHUR would be going? DODRILL would not say where she would be headed. DODRILL advised that he has been in and out of jail and this "would be against the way he works."

When I arrived at Rite Aid, Officer Hilfiker was there speaking to KNEPPER. I had DODRILL step out of the car so KNEPPER could get a look at him. KNEPPER advised that it was in fact the same male. KNEPPER had told Officer Hilfiker that when he was following the suspect auto, he was able to get next to the car before they realized they were being followed. This is when he got a good look at the male suspect and this is why he is sure that we had the right male.

Officer Hilfiker also spoke to WIT/JENNIFER S. BROWN and she related the following. BROWN was working the front counter of the store. BROWN observed DODRILL run out of the store with a basket full of misc. items. BROWN then called out to KNEPPER and this is when KNEPPER ran after DODRILL.

Officer Hilfiker received a list of the stolen items from KNEPPER. They were as follows: Two packs 65 count of Pepcid, two 50 count packs of Pepcid, four packs of 42 count Prilosec, eight packs of Gillette Fusion Power Razors, two packs of Phillips Sonicar toothbrushes. All of these items totaled \$665.70.

DODRILL was transported to the station and booked in by CO'S McCarthy and Bunner for Felony Theft and Warrant Other Agency. DODRILL had a warrant from Adult Parol Authority for Probation Violation and was later confirmed by their agency via TTY by K. CAMPBELL.

Dispatch contacted the Medina Police Dept. and asked them to check ARTHUR'S last know address to see if she was there. Medina Police Dept. advised that the car was not there.

KNEPPER called LPD to advise that he had made a copy of the video recording showing DODRILL taking the items and leaving the store. Officer Wintrick responded to Rite Aid and picked up the video. The video recording was tagged by this officer and placed in evidence locker #11 in the LPD property room.

At approx. 0030hrs. on 06/20/08, OIV/POLLY DODRILL contacted LPD and first spoke with PO RUSNAK and then Sgt. L. WILKINS. POLLY is JAMES' mother and wanted us to be aware of the fact that ARTHUR was in fact driving the suspect auto today. POLLY advised that she had spoken to her son, while in jail, and he had told her this while on the phone with him this evening. She doesn't have a current home address for her son and claims that he is homeless due to an addiction to heroin.

POLLY related that ARTHUR is currently living with a male by the name of "SAMMY" and they may be in the area of West 78th Street. They have two (2) kids and "SAMMY" knows DODRILL through being incarcerated together in Richland Correctional within the past six (6) months. POLLY was thanked for her time.
