Topic Original Report

M.O.:By opening the east kitchen window and climbing into the residence without permission.

On 6/20/08 at 1215 hrs., I responded to 1475 Newman Ave. on report of a possible burglary at that address. On arrival, I met COM/SCOTT TURSKI. TURSKI said that he was the owner of the building at 1475 Newman Ave. He said he was there working on the back porch, when he noticed that the east kitchen window was slightly open. He explained that there was a burglary at the address earlier in the week, see report 08005024, and he knew the window was completely closed prior to 6/20/08.

TURSKI said he left the house on 6/18/08 at 1430 hrs. and knew the window was closed. He said that he was watching the house for his tenant, VIC/MARIE HARGES, because she was in Maryland on vacation. TURSKI stated he also noticed that the storm door, leading from the kitchen door to the outside, was ajar on 6/20/08. TURSKI said he also tried the kitchen door and it was unlocked; he said he knew that was locked on 6/18/08.

The window to the kitchen that TURSKI pointed out was open about 3/4" wide. There was black powder on the window frame that appeared to be disturbed. It appeared to be fingerprint powder from the last incident when the window was processed.

Inv. Kulczycki arrived to assist. We checked the house but found nothing apparently amiss and noone inside. I spoke with HARGES on the telephone; she had us check the residence for any missing valuables. Everything she had us check for was still in the house.

HARGES said she stacked some pots and their lids in front of the kitchen window so that if someone tried to climb through, they would fall. I told her that the pots were stacked on the stove, south of the window opening, and the lids were on the counter, north of the opening. She said she was sure that someone would have to move them to get inside the window. HARGES said she could not lock the window because the lock did not work. She said she suspected SUS/AL GEORGE as the person responsible for entering the house. HARGES said GEORGE was the suspect in the previous burglary because he knew when she would be gone.

I asked HARGES if she asked any neighbors to watch the residence. She said she did, and said that OIV/CISELY KOSTELNIK was helping to keep an eye on the house. I spoke with KOSTELNIK while Inv. Kulczycki processed the house. See his supplement for additional details.

KOSTELNIK said she was aware of the problem that HARGES had and did see a suspicious black male in the area on 6/18/08 at about 1100 hrs. KOSTELNIK said she knew the male to be HARGES's daughter's ex-boyfriend, GEORGE, although she did not know him by name. KOSTELNIK she first saw GEORGE walking up and down the street, looking at houses in the area. KOSTELNIK said that GEORGE then knocked on her front door. She said that when she answered, GEORGE first asked her if a Russian family moved out from her residence. She said she told him she did not know anything about them. GEORGE then asked to buy some cigarettes from KOSTELNIK, according to KOSTELNIK. She said she sold him four cigarettes, then he left. KOSTELNIK said she did not remember which way he went when he left her house.

KOSTELNIK gave me the listed description for GEORGE. As I spoke with KOSTELNIK, a male who

identified himself as her boyfriend, OIV/MARK YOST, stood with her. YOST seemed nervous and did not speak while I spoke with KOSTELNIK. I asked him if he saw GEORGE or knew anything about the incident. He said he did not see GEORGE because he was gone at the time GEORGE stopped at the house.

I later checked YOST's D.S., and learned he had a local arrest warrant from Parma P.D. for Contempt of Court. YOST also had numerous arrests in CRIS, some for theft and forgery offenses, in addition to a misdemeanor C.C.W. arrest.

TURSKI said he would secure the window with a board to prevent it from opening so easily.
