Topic Original Report

M.O.: By entering the apartment and taking the listed items without the owners knowledge or consent.

On 6/22/08, at 0147 Hrs, Inv. Register and I responded to 2019 Quail Apt#2. When we arrived on scene we spoke with VIC/CATRINA DAMON and learned the following:

DAMON's mother passed away on 6/19/08. The Coroner's Office responded at this time and sealed her mothers bedroom. DAMON stated she has been staying a friends house since the incident, but returned for a short time on 6/21/08 at approximately 0030 hrs. The apartment was not disturbed at this time. When DAMON returned to get clothing this evening, she found her mothers bedroom door opened, her drawers opened, and some of her belongings missing. DAMON's friend, OIV/SHANNON JACKSON, contacted the police immediately.

While I spoke with DAMON, Inv. Register contacted the Coroner's Office and spoke with Inv. Teel. Teel indicated the case was closed on 6/19/08.

2019 Quail #2 is a two bedroom apartment. DAMON's bedroom is located in the southwest corner. DAMON stated approximately 20 pair of her underwear were taken from the top left drawer of her dresser, which was located along the east wall. A vibrator was taken from a box that was located in the living room on the tv stand, which was located along the west wall. DAMON was unsure what her mother had in her bedroom and was unable to determine if anything was missing.

There was no evidence of forced entry into the apartment. DAMON stated she locked the door when she left on 6/21/08, and she had to unlock the door to enter this evening. DAMON stated her mother had given several friends a key to the apartment.

When I asked DAMON if she had any suspects, she stated her mother's ex-boyfriend, SUS/ANTONIO PENA, was a "pervert" and capable of committing this crime.

DAMON believes her mother had given him a key.

After DAMON's mother passed away, PENA contacted her. DAMON stated PENA wanted some pictures his mother had once given him. DAMON stated her mother had sent PENA pictures of herself while he was in prison.

Inv. Register processed the scene, but found nothing of value.

PENA has a CCH, BCI#A904009, FBI#641508AA2, LPD#17088.
