Topic Original Report

Sgt. Eschweiler, Sir:

On 6/22/08, at 0147 hours, I was detailed to 2096 on a report of a possible burglary. On arrival I spoke to OIV/ MARGARET KERR and COM/ PAUL KERR and learned the following: They advised that they left for vacation on 6/11/08 at 2030 hours. They took their three children, OIV/ \_\_\_\_\_, OIV/ \_\_\_\_\_ and OIV/ ERIN KERR with them. They advised that they locked their doors and closed their windows prior to leaving.

MARGARET and PAUL arrived home today at 0115 hours. When they went into the kitchen they noticed various lights on throughout the house. Two kitchen windows were open, but the screens were closed. She found a bath towel cover the north window in the kitchen. She found dirty dishes in the sink, but advised that the sink was empty prior to leaving. She found the playstation video game console on the floor in the livingroom and stated that it was inside the entertainment center. She found her dust pan on the diningroom table with tobacco residue on the table cloth. PAUL advised that most of the lights in the house were on timers, but found the timers unplugged and the lights plugged directly into the wall. They advised that nothing in the house was missing.

MARGARET and PAUL advised that their children were in asleep. They had no suspects and advised that prosecution was desired. They were advised of the solvability factors.

INV REGISTER responded to the residence after I had cleared the scene. At this time ERIN was awake and advised INV REGISTER that she told her friends that her whole family would be out of town and they could hang out at her house. She left her bedroom window open and her friends used a ladder that was behind the garage to enter the residence. MARGARET and PAUL advised that they no longer desired prosecution and they stated that they would handle the situation with ERIN and her friends.
