Topic Original Report

MO: By entering residence by unknown means and taking listed laptop, television set and microwave sandwiches without owners permission

On 6-23-08, at 0900Hrs., I was detailed to 1299 Idlewood Ave. to take a burglary report.

On arrival I spoke with VIC/KIMBERLY WILSIE who relayed the following. She left her home last evening around 2100Hrs. and was certain that she locked both of her doors. WILSIE stayed the night at her boyfriends home and returned around 0830Hrs. this morning to find her back door slightly ajar. Upon entering, WILSIE discovered her television and laptop computer gone from the front room.

WILSIE immediately suspected two females. prior tenants of her unit, the downstairs half of the home. She went on to explain that SUS/ and SUS/JACQUELINE WEBB neglected to give her one set of keys to her unit, about six months ago when she moved in. moved to the upstairs of the home, 1301 Idlewood. (A male friend of , SUS/BRANDEN GRAHAM, moved in with her about a month ago.) In addition to the issue over the keys, WILSIE had a falling out with and WEBB regarding male friends that they had in common. WILSIE has suspected them of entering her home before and damaging her vehicle outside. She did not contact our department regarding this.

WILSIE stated that prior to my arrival, she spoke with GRAHAM upstairs. He stated that he was gone for a portion of last evening and did not hear or see anyone around her place. was not home for WILSIE to confront.

WILSIE stated that she is actually friends with GRAHAM and that she did not suspect him of taking her items.

WILSIE showed me to the front room which she uses as a bedroom. On a television stand was an empty space where she indicated the listed TV had been taken from. Adjacent to this is a small table where she pointed out the laptop was taken from. She advised that nothing else was disturbed.

There were no signs of forced entry found to the doors or windows.

WILSIE also indicated that she noticed that two "Hot Pockets" microwavable sandwiches were missing from her freezer.

The condition of the apartment was poor, with clothes and items thrown about.

INV. GEARY responded for ET work and found nothing of value.

I spoke with GRAHAM who advised that he was gone last evening from 2100 to 2300 or 2400Hrs. He was then awake until about 0300Hrs. Prior to falling asleep, he heard WILSIE's three dogs bark for about fifteen minutes. GRAHAM did not hear any footsteps or doors closing downstairs. He stated that was not home last evening or at the time of this report. GRAHAM was not aware of her whereabouts.

WILSIE advised that the dogs were in cages while she was gone.

WILSIE provided me with the serial number that she had on paperwork for the laptop computer. She was not certain about the brand of TV and had no paperwork for it. Dispatch later entered the laptop into the computer as stolen.

WILSIE gave me a phone number for WEBB. She believed WEBB's last name to be Lane. Information I obtained showed her current address on Athens Ave. She had little information on Jordan Williams. GRAHAM could provide no further. The listed MIN was found in CRIS and believed to be her.

While conducting a canvass with neighbors, I was approached by OIV/MARY LOU MONSOUR, who lives across the street at 1302 Idlewood. She stated the following. She was on her upstairs porch around 2300Hrs. last evening when she saw a familiar male. MONSOUR recognized the male since he is often at WILSIE's home, visiting both the upstairs and downstairs units. MONSOUR advised WILSIE that she saw the male sitting on the porch and pacing around the front of the home for about half an hour. MONSOUR went back inside for the evening when the male was still sitting on WILSIE's porch.

MONSOUR found it odd that WILSIE would deny knowing the male since he is over there so much. She further stated that the male lives over at the youth program in the apartments behind her, 11849 Clifton Blvd.

While on scene, I asked WILSIE and GRAHAM if the suspect was familiar to them. They claimed not to have any idea who he may be.

WILSIE stated that she desired prosecution in this matter.

While on scene the computers were not working. A few hours later I ran the involved persons through the computer and found that GRAHAM has a felony warrant with GOV/CCSO for Burglary. I later returned to the residence to try and locate him but found nobody home.
