Topic Original Report

MO: By entering the victim's open garage and leaving the garage with the victim's bicycles without permission of the owner.

Lt. Sprague, Sir:

On 6/23/2008, at approximately 0859 hours, I was detailed to 2096 Lincoln on the report of bicycles being stolen from a garage. I arrived on scene and spoke with COM/ PAUL KERR. He advised the following.

On 6/23/2008, at approximately 0855 hours, he went outside his residence into his garage. He noticed that the two listed bicycles were missing from the garage. He contacted his wife, VIC MARGARET KERR, via telephone and confirmed with her that she did not have possession of the bicycles. He stated that his wife confirmed that the bicycles were in the garage when she left her residence for work at 0530 hours this morning. KERR stated that he spoke to his children and confirmed that they did not use the bicycles or have any knowledge of their whereabouts. PAUL then contacted LPD to report the theft of these bicycles.

I spoke to PAUL about the status of the bicycles. He advised that they were last seen in the North corner of the garage. He stated that the North door, visible from the road, was left open due to a problem with the rollers on the garage door. He stated that this door was left open throughout the day of 6/22/2008 until the time of my arrival. PAUL advised that there were no other items missing from the garage.

Inv. Moher responded to the scene for processing. He was unable to retrieve any usable evidence from the scene.

I was able to confirm that the girl's Savannah Trial bicycle was licensed with the City of Lakewood, License Number 11608. The listed boy's Quest bicycle was not licensed in the City. However, PAUL supplied a sales receipt from Dicks Sporting Goods that included the serial number of the bicycle. I supplied this information to dispatch so that the serial numbers of the listed bicycles could be entered as stolen. The NIC # for the listed girl's bike is A546331045 and the NIC # for the listed boys bike is A026275626.

PAUL advised that he did not see or hear any suspicious activities or persons from 0530 to 0855. He advised that he does not have any suspects. He advised that he desires prosecution. PAUL and MARGARET were advised of the solvability of this matter.
