Topic Original Report

MO/ By punching victim in the mouth and knocking out victim's teeth.

On 6-26-08, at 2246 hours, units were detailed to 12400 Madison on a report of a male that had just been assaulted. Dispatch advised 3 males suspects had left walking NB on Ridgewood. One of the suspects was very tall and wearing black clothes. Units checked the area for the suspects with negative results. WIT/MCDONOUGH called in the complaint.

Dispatch advised the victim was bleeding heavily from the mouth. They dispatched squad 3 to the scene.

VIC/SCHILL was located by the front door of the Fedor Manor. His mouth was bleeding and he was missing teeth from the front of his mouth. SCHILL stated he was standing where he was assaulted. In checking the ground we recovered several teeth and parts of teeth. It appeared as if we recovered 3 1/2 teeth. The teeth were turned over to LFD in squad 3.

SCHILL stated he was standing outside of the Fedor Manor waiting for his brother. He was approached by 3 males. SCHILL recognized one of the males as SUS/VAZQUEZ. SCHILL stated he used to date VAZQUEZ's mother. He stated he hasn't seen them in 2-3 years.

VAZQUEZ said "hey", to get SCHILL's attention. When SCHILL looked at him, VAZQUEZ punched him in the face. This knocked SCHILL to the ground. SCHILL claims VAZQUEZ continued to punch him in the face when he was on the ground. The males left walking NB on Ridgewood.

According to SCHILL, VAZQUEZ was wearing a black shirt and black pants. He did not have a description of the other two males. The other males did not assault SCHILL. SCHILL desires prosecution against VAZQUEZ.

SCHILL was transported to the ER by Squad 3. He was treated and released by Dr. Nelson at the ER.

I spoke to MCDONOUGH. He was at the Fedor Manor getting a newspaper. He said SCHILL was standing by the door when three WM approached him. He stated a tall male wearing black walked up and punched SCHILL. SCHILL went backwards to the ground. SCHILL went down out of his line of sight and the tall male approached him again. MCDONOUGH was unsure if the tall male hit SCHILL again after he was on the ground.

INV DEUCHER responded to take photos of SCHILL's injuries. It should be noted he had some scratches on the back of his left elbow. It should be also noted that SCHILL appeared to have been consuming alcohol. Due to his injuries I was unable to determine his degree of intoxication.
