Topic Original Report

M.O.: By prying open a window, entering victim's apartment, and taking money, a credit card, and alcohol, without the victim's permission.

Lt. Warner, Sir:

On 06/26/2008, at 2322 hours, officers were dispatched to 2275 Warren Rd., Apt. 106, on the report of a burglary. On arrival, I met VIC/MARY K. SPITZER. MARY advised that, as she was leaving her apartment at approximately 2000 hours, on 06/26/2008, she saw SUS/RICHARD D. ROGERS sitting in a blue SUV or pickup truck in the driveway of the apartment building's parking lot.

MARY explained that she used to date ROGERS, and that ROGERS lived with her in the apartment. ROGERS moved out in September 2007 when the two broke up, due to ROGERS' alcohol abuse. MARY stated that ROGERS still frequently comes over to her apartment to ask for money. MARY advised that ROGERS is an alcoholic, and probably does not have a job.

MARY walked out to the vehicle, and told ROGERS to leave. As MARY went back into her apartment, in the basement of the building, ROGERS pulled into a spot in the parking lot directly in front of MARY's living room window and repeatedly and loudly revved the engine. SPITZER walked back out to ROGERS, and again told him to leave her alone. SPITZER then got in her vehicle and left to run some errands. Nobody was in the apartment when SPITZER left.

At approximately 2227 hours, on 06/26/2008, MARY's son, OIV/ who lives with MARY, came home. noticed that coins in U.S. currency, kept in a small bowl on a table in the living room, were missing. called MARY to inform her of this. MARY returned home at 2315 hours, on 06/26/2008. MARY noticed that a window in her bedroom was open, with the screen pried out. She observed the screen, badly bent, laying in the bushes outside the apartment. MARY then called LPD.

MARY stated that a \$1 bill, as well as assorted change in U.S. currency, was missing from the top of the dresser in her bedroom. Also missing was a Chase Bank VISA credit card from the top right dresser drawer. MARY advised that she called Chase and cancelled the credit card. Chase informed her, however, that at 2241 hours, on 06/26/2008, \$6.78 was charged to the card at the intersection of Jennings Rd. and Brookpark Rd. in Parma. Another charge, for \$19, was made at the intersection of State Rd. and Brookpark Rd., at 2246 hours, on 06/26/2008. Chase also advised MARY that a third attempted charge on her credit card was declined, at 2329 hours, on 06/26/2008, at the intersection of Fleet Rd. and E. 49th St. Chase was unable to provide the names or addresses of the stores at which the charges were made or attempted, only the intersections.

MARY further advised that approximately eight bottles of Miller Light beer, four wine coolers, and one bottle of wine, were missing from her refrigerator.

MARY had no further information on the vehicle ROGERS was driving, describing it only as a blue pickup truck or SUV. ROGERS has no vehicles registered in his name.

MARY indicated that ROGERS does not have a key to her apartment, but that ROGERS, when he lived

[REDACTED] with her, would enter the apartment through that same window when he forgot his key. MARY suspects ROGERS is responsible, and desires prosecution in the matter. MARY was advised regarding obtaining a protection order.

Inv. Deucher processed the scene for evidentiary purposes.

ROGERS has a CCH, FBI number 257436NA2, BCI number B369476, listing a prior conviction for aggravated burglary, among others.
