Topic Original Report

Sgt. Kauchek, sir:

On 6/27/2008, at 2155 hours, I was dispatched to 1126 Summit on a call from COM/BRYAN CURRIE stating his apartment had been entered and a television taken.

Upon arrival, I spoke to BRYAN who stated the following: BRYAN arrived home today at approximately 1800 hours to find the back door to his apartment had been forced open. The door was ajar and the deadbolt strike plate was dislodged from the door frame and it was found in the middle of the kitchen floor. BRYAN checked his apartment and discovered a television missing from the back bedroom. This is the bedroom of BRYAN's roommate and cousin, OIV/HEATHER CURRIE, who is the owner of the missing television.

BRYAN stated he had been out of town since Tuesday, 6/24/2008. BRYAN and HEATHER are in the process of moving out and BRYAN thought HEATHER may have moved the television while he was out of town. BRYAN also thought HEATHER may have lost her keys and forced the back door open. Upon contacting HEATHER, BRYAN learned she had not taken the television or forced the door. HEATHER told BRYAN she was home for only a few minutes Wednesday evening at approximately 1800 hours, but did not go to her bedroom or the kitchen.

The back door of the upstairs apartment is accessed from a back stairway. The back door leads to a kitchen area. Past the kitchen area is a living room. A 52 inch flat screen TV, an Xbox game system, and other audio/video components were still in the living room. Towards the front of the apartment is an office area. A Mac G4 computer and monitor were still in the office area.

Down the hallway from the living room area are two bedrooms. The last bedroom belongs to HEATHER and holds a bed, a dresser and other furniture. BRYAN stated HEATHER's 32" flat screen TV usually sits on the dresser.

Inv Pickens arrived to photograph the scene. Nothing else of evidentiary value was found.

BRYAN stated he has renters insurance but did not know if HEATHER did. BRYAN stated he did not care about the damage to the back door because he is moving out and the landlord does not return his calls. BRYAN was given this report number and stated he would advise HEATHER to contact Lakewood PD as soon as possible. BRYAN stated HEATHER works in the Sandusky area and did not know when she would return to Lakewood. On 6/28/2008, I left a message for HEATHER asking her for more information. To this date HEATHER has not returned my call or contacted Lakewood PD regarding prosecution.
