N A R R A T I V E 1	Topic Original Report	<p>M.O. By entering the listed vacant residence and taking copper piping without permission of the victim.</p> <p>On 06/27/2008, at 1801 hours, Inv. Fioritto and I were detailed to 1222 Bonnieview Ave. for a Breaking and Entering report. Upon arrival, we spoke with COM/DAVID HASH who lives at 1220 Bonnieview Ave. HASH stated, at around 1800 hours, he noticed the back door of 1222 Bonnieview Ave. standing wide open. HASH stated he yelled into the house but did not hear anyone inside. HASH advised he has been keeping an eye on his neighbor's house because it has been vacant for a couple of months. HASH stated the last time he noticed the door on 1222 Bonnieview Ave. shut was on 06/26/2008 at around 1800 hours. HASH advised there have been numerous people in and out of the house on a daily basis. HASH stated people come to maintain the yard and others come to look at the house because it is for sale.</p> <p>Inv. Fioritto and I entered 1220 Bonnieview Ave. through the open back door of the house. The door was a sliding glass door which is secured by only a latch. The door could be opened when pushed in, lifted and then pulled to the rear to open. We checked the house and found copper piping cut, by an unknown instrument/tool, from the 1st floor kitchen and bathroom and also the second floor bathroom. We also found copper piping cut from the basement. There was, however, copper piping still on the third floor bathroom and in the basement cubby holes. Due to the unknown amount of copper piping throughout the house, we estimated approximately 150 feet of copper missing. There is also galvanized piping and PVC piping throughout the house. Inv. Fioritto photographed and processed the scene. Inv. Fioritto was unable to locate any prints. We secured the back sliding door with a wooden stick to prevent the door from being opened. We exited the house through the side door and was secured upon departure.</p> <p>After looking through the house, I attempted to speak with the residents at 1221, 1225, 1228, 1229, and 1230 Bonnieview Ave. There was no answer at any of the above addresses. I was able to make contact with the residents of 1221 Granger Ave., the house directly behind 1222 Bonnieview Ave. There is a clear view of the back door from this residence. I spoke with MEGAN and JAMIE HYLTON. JAMIE and MEGAN advised they had not noticed anyone out of the ordinary at the house. They advised there are people constantly in and out of the property. MEGAN stated she is usually home during the day.</p> <p>According to the Cuyahoga County Auditors web site, the property is owned by VIC/DEUTSCHE BANK NATIONAL TRUST. No other contact information was available for this property. The VIC/DEUTSCHE BANK NATIONAL TRUST is an internationally owned bank with offices throughout the U.S. They do not have any offices located in the State of Ohio.</p>
