N A R R A T I V E 1	Topic Original Report	<p>MO/ By entering apartment through unlocked 2nd floor window and taking property of value without owner permission.</p> <p>On 6-27-08, at 0431 hours, INV DEUCHER and I were detailed to 1342 Hird #6 on a report of a burglary. On arrival we spoke to VIC/MILLER. MILLER left her house at 2300 hours on 6-26-08 and returned home on 6-27-08 at 0400 hours. When she returned home she found her apartment was not as she left it.</p> <p>The bedroom window on the West side of the apartment was found open. Her bed is by the window and the sheets were messy. She found some potato chip cans that were in her bedroom closet were on the floor of her room. She kept money in these cans and the money was missing. She estimated there was a combined total of \$550.00 in the 3 cans. Three pairs of shoes were also missing from the closet. Her bedroom dresser had been rummaged through but nothing was missing. Nothing else in the rest of the apartment appeared to have been gone through.</p> <p>MILLER stated her apartment door was locked when she got home. There were no signs of force to the door. The door will lock behind a person leaving and is likely be the exit point. MILLER lives alone and no one else has a key to her apartment. The bedroom window was unlocked and wide open. MILLER stated the window was unlocked but closed when she left on 6-26-08. MILLER believed the window was the entry point. The window was 11 feet off the ground. It did not appear to me as if someone would be able to climb through the window from the outside without a ladder. In the past, MILLER has made it into her apartment by boosting a person up to the window.</p> <p>MILLER had no suspects in the incident. She did not think anyone knew she kept cash in the cans. She couldn't think of anyone who knew she was going to gone from her apartment.</p> <p>MILLER was advised of the low solvability factor. She desires prosecution.</p> <p>INV DEUCHER took photos of the apartment. He recovered a latent from the interior side of the bedroom window.</p>
