Topic Original Report

MO: By entering the apartment through unknown means, obtain the owner's purse and exiting the apartment with same without the permission of the owner.

Sgt. Wilkins, Sir:

On 6/27/2008, at approximately 0918 hours, Ptl. Rebraca, Inv. Crumley and I were detailed to 2073 Robin #1 on the report of a burglary. Ptl. Rebraca and Inv. Crumley arrived on scene and were met by VIC/ CASSANDRA BIDDULPH. I arrived on scene a short time later. BIDDULPH advised the following.

On 6/27/2008, at approximately 0900 hours, she woke after falling asleep on her living room couch for the night. She stated that she used the restroom and proceeded to the basement to change out a load of laundry. BIDDULPH advised that this took approximately 10 minutes. She stated that she returned upstairs into her family room to find that the West front window was open. She indicated that she then noticed that the listed purse along with its listed contents, which was on the end table approximately 10 feet from the window, was missing. She stated she double checked her apartment and could not find the purse or its contents. Following this, BIDDULPH contacted LPD via telephone to report this incident.

BIDDULPH resides in a single bedroom apartment by herself. The area where the purse was located is the family room. The front window faces the West and has the front door directly to the North of it. BIDDULPH advised that the front West window was closed, but not locked. She stated that the front door was locked. She advised that she did not hear any activity in the front of the residence while she was in the basement. BIDDULPH stated that the other residents in the apartment have access to the basement area of the apartment and would have had access to her apartment with her kitchen door open. She stated that she did not hear any activity in the common hallway while she was in the basement.

It should be noted BIDDULPH provided conflicting information regarding this event when asked about the details. She advised that she received \$500 in cash from an unknown male to satisfy a debt. She stated that this male was an associate of her boyfriend, OIV/ DARIAN MCCARROLL. She was unable to provide a concrete time that this male dropped off the money at her apartment, varying from 2300 hours on 6/26/2008 to 0100 hours on 6/27/2008. BIDDULPH also claimed that she was switching laundry from the washer to the dryer when she went to the basement. Inv. Crumley and Ptl. Rebracca inspected this area in the basement while checking the residence for possible intruders. Inv. Crumley noted that the dryer and clothing inside it that was exchanged did not appear to have been dried recently, as both were cool to the touch. BIDDULPH was unable to provide a satisfactory explanation for this. Finally, she claimed that the West front window was not able to be secured and that it was the probable point of entry as a result of this. Inv. Crumley was able to secure the window easily, using the locking latch on top, after processing it for evidence. Inv. Crumley also noted the condition of the window blinds that were reportedly down at the time of this incident. They did not appear to sustain any damage that may be expected from a person entering and exiting the window with the blinds down.

BIDDULPH indicated her aunt, SUS/ MEREDITH DIVINE, could also be a suspect in this matter. She stated that DIVINE confided in her on 6/26/2008 that she relapsed on heroin. BIDDULPH reported
