Topic Original Report

M.O.-By having in vehicle, where all were present, the listed marijuana pipe.

On 6-28-08, at approx. 2118 hours, I was on routine patrol in the area of Fry and Detroit and observed the listed vehicle in front of me. I ran the plate as a random license plate check and found that the plate expired 6-9-08. The vehicle was stopped in front of 1360 Fry.

I approached the vehicle and spoke with the driver, ARA-FLEMING, and advised him of the reason for the stop. FLEMING stated that he was headed to the front seat passenger's home, ARA-JUCHNIK, after dropping some friends off at the Five O'Clock Tavern on Detroit. FLEMING was asked who he dropped off and he could not tell me. I asked him if he anything illegal in the vehicle such as drugs or weapons and he stated, "not that I know of." I then asked FLEMING for a consent to search his vehicle for contraband and he advised that I could.

I had all three occupants step form the auto to perform the search. PO Hayes arrived as back-up at this time. The other occupant, ARA-VIDOVIC, was in the passenger side rear seat. During the course of the search, I located a silver pipe with burnt marijuana residue inside same. The pipe was located in the seat pocket on the back of the front passenger side seat. All three denied ownership of the pipe. No further contraband was located.

As a result of the search, all three parties were issued misdemeanor citations for Drug Paraphernalia. FLEMING was issued citation #D162432 for Expired Plates and No Seat Belt. JUCHNIK'S misdemeanor citation issued was #M40724, FLEMING'S citation was #M41176 and VIDOVIC'S #M40724.

The pipe was confiscated, tagged and secured in the property room chute to be held for evidence.
