Topic Original Report

M.O. By having .81 grams of heroin, a spoon with heroin residue, and a syringe on his person.

On 06/28/08, at 0010 hours, P.O. RUSNAK, INV. ALLEN, and I were detailed to 15203 Athens on a call from COM/JAMES A BAESEL. JAMES advised that his son, ARAWESLEY J BAESEL, possibly overdosed on heroin. LFD Squad #1 and Engine #1 were also dispatched. On arrival, we learned the following:

JAMES advised that WESLEY was recently released from a halfway house. He was going through rehabilitation for his drug problem. JAMES allowed WESLEY to stay at the house just for the evening. WESLEY went into the bathroom on the first floor. JAMES advised that WESLEY was still in the bathroom 30 minutes later. JAMES could not open the door. He contacted the police.

Squad #1 paramedics and officers arrived and opened the door. We found WESLEY lying on the floor, face down. WESLEY had his boxer shorts and khaki shorts around his ankles. Squad #1 paramedics lifted WESLEY's shorts around his waist, and the indexed cigarette pack with a syringe fell out of the pocket. INV. ALLEN opened the cigarette pack and located paper wrapped in cellophane. The contents inside the paper were later tested and determined to be heroin. JAMES assisted officers in locating a silver spoon in the bathroom with heroin residue.

WESLEY signed a refusal to be transported to the hospital. He was advised that he was under arrest for possession of heroin. WESLEY was handcuffed and secured in car 204. He was transported to the station where he was booked in and strip searched by P.O. PERHACS.

The heroin bindle located in the cigarette pack, the spoon with residue, and the syringe were confiscated, tagged, and secured in the property room. The heroin field tested positive. The gross weight of the bindle totaled .81 grams.

WESLEY has a CCH with prior drug convictions. (FBI/668600PA8, BCI/B402897)
