Topic Original Report

M.O.: By threatening the VICs with a handgun while committing a Theft offense, causing them to fear for their life, and then leaving the area with the VICs property.

Sgt. L. Wilkins, Ma'am:

On 6/29/2008, at 0040 hours, officers were dispatched to Bonnieview in the area of Oak Tree Manor, on a call from VIC/COLLEEN HUGHES, stating she had just been robbed at gunpoint. The SUS was described as a light skinned B/M wearing a white Tshirt and jean shorts.

While en route, dispatch advised the SUS ran N/B on Bonnieview and was last seen heading east approximately ten to fifteen houses north of the railroad tracks. PO SCHAD and ARCO arrived to assist. Officers established a perimeter and checked the area but with negative results.

Officers Ortiz and Hayes spoke with VIC/VICTOR MAAR, VIC/ANGELA GRAY and VIC/COLLEEN HUGHES. Each VIC provided written statements and desire prosecution.

MAAR stated the following: MAAR and HUGHES were walking S/B on the east side of Bonnieview from his residence at Bonnieview. As they passed the Oak Tree Manor, the SUS approached them from the west side of Bonnieview. The SUS pointed a silver handgun and demanded money from MAAR. MAAR handed over his wallet which contained his driver's license and credit cards. The SUS took HUGHES' wrist wallet and ran N/B on Bonnieview, firing the gun in the air as he ran. MAAR followed the SUS and watched as he then approached a vehicle parked on Bonnieview near the railroad tracks. The SUS stopped at this vehicle for a couple of moments and then ran N/B on Bonnieview. He was last observed turning east into a yard approximately ten to fifteen houses north of the tracks.

HUGHES stated the following: HUGHES was walking with MAAR S/B on Bonnieview when they were approached from the west side of the street by the SUS. The SUS was holding a silver gun in his right hand and demanded money from MAAR. MAAR told the SUS he had no money and handed over his wallet. The SUS turned attention to HUGHES and she handed over her "wristlet," a wallet which is worn on her wrist. The wristlet contained HUGHES' driver's license, credit card and approximately ten dollars. The SUS pointed the gun away from MAAR and HUGHES and fired it. He then pushed HUGHES away and said, "Get out of here." The SUS left N/B and HUGHES called 911 on her cell phone.

GRAY stated the following: GRAY was parked in front of 1328 Bonnieview and the SUS approached her vehicle on the passenger side. The passenger window of GRAY's vehicle was partially open and the SUS pointed a small silver handgun through the opening. The SUS demanded GRAY's wallet. GRAY handed over her wallet which contained her driver's license. The SUS left N/B on Bonnieview. GRAY left in her vehicle S/B on Bonnieview and was able to alert a CCSO Deputy at Bonnieview and Detroit.

To clarify, VICs/HUGHES and MAAR were the first to get robbed. VIC/GRAY was the second. Both incidents happened a few moments apart from each other. MAAR observed the SUS approach GRAY's vehicle and he continued to run after him but the SUS was lost 10-15 houses north of the RR

The SUS was described by the VICs as a light skinned B/M with very short hair, large ears, approximately 6'2", thin build, wearing a white Tshirt and dark jeans shorts. The SUS held a small silver handgun in his right hand.

The VICs could not provide the various credit card numbers that were taken as a result but were advised to contact LPD when they could provide same. It should be noted that several Officers, that had been checking for the SUS, then responded to the area of the Drink Cafe and McCARTHY's to see if anyone had witnessed anything of value. This proved to be unsuccessful.
