Topic Original Report

MO-By entering the victim's home and taking copper piping without permission to do so.

Detailed on 7-1-08 at about 1519 Hrs. to 1299 Fry Ave. on the report of a home that was Burglarized. On arrival I spoke to COM/JOYCE PEDEN who advised the following.

PEDEN is a long time friend of the family of VIC/CATHERINE MAXEY and OWN/JAMES MAXEY. PEDEN stated that JAMES passed away on 10-3-07. Since that time PEDEN has been watching over JAMES' home for CATHERINE while she gets things in order for Probate Court. PEDEN stated that it has been at least three weeks since she was last at the home. PEDEN stated that on her arrival today, she noted that someone had broken out the N/E corner basement window and likely entered the home. Due to JAMES being described as a "pack rat", PEDEN found it difficult, if not impossible, to tell what had been taken from the home. It was also unable to be determined what areas inside the home had been targeted by the suspect(s).

PEDEN stated that the home had been broken into once before and secured as best as she could then. This incident was not reported previously. PEDEN stated she feels as though the party responsible was someone known to JAMES. PEDEN stated that in the last few months of his life, JAMES befriended several "street people". PEDEN has no idea who these parties may be.

PEDEN stated she contacted CATHERINE about the incident. CATHERINE advised she wanted a police report made. PEDEN then called LPD to do so. PEDEN was advised on the report and given the number for the records. PEDEN stated she would again try her best to secure the home against further attacks.

Prior to completing this report, PEDEN was found to have called back and left a message for this Officer. When contacted, PEDEN stated that the copper pipes were missing from both the first and second floor. PEDEN was unable to respond back to the property for ET work at this time but stated she would be available if given adequate notice. PEDEN was advised that may be arranged once Detectives received this report for follow up.
