| <p>MO-By unknown means, enter the victim's home and take copper piping without permission to do so.</p> <p>Detailed on 7-1-08 at about 1601 Hrs. on the report of a home entered and copper pipe taken. On my arrival I spoke to COM/JEFFREY COLLISON who advised the following. COLLISON is one of a number of contractors working for OIV/SCOTT SCHRAFF who is the trustee for VIC/E. WINCHESTER TRUST. COLLISON stated that the home is openly advertised for rent and has a contact number posted on a sign in the front yard.</p> <p>COLLISON stated his crew just got done remodeling the entire home. The last time COLLISON stated anyone had any business at the home was on 6-29-08. COLLISON stated he and another employee returned on this date to finish putting on a cabinet face for the first floor unit. In checking that unit, COLLISON found that all of the copper pipe had been removed from underneath the sink. COLLISON then began checking the rest of the home for other damage. COLLISON found that the copper had also been taken from a second floor bathroom as well as the entire basement. COLLISON then called SCHRAFF and left a message. COLLISON then called LPD to make a report.</p> <p>Inv. Malloy responded to the scene for ET however no latent prints were recovered. See his photo sheet for details.</p> <p>In checking the home, no point of entry could be found. It is possible that a realtor could have shown the home to a prospective tenant and forgot to re-secure a door.</p> <p>COLLISON was advised on the report and given the number for his records. Should a suspect be developed COLLISON is sure E. WINCHESTER TRUST would desire prosecution in this matter.</p> | | |
