1	<p>M.O. 1: By opening screen and attempting to open window into victim's house.</p> <p>M.O. 2: By taking a bicycle and a box of tools from open unattached garage, without the owner's permission.</p> <p>Sgt. Eschweiler, Sir:</p> <p>On 07/01/2008, at 2156 hours, I was detailed to 2040 Warren Rd., on the report of a stolen bicycle. On arrival, I met VIC/ANTOINETTE M. RANDLE, who lives at the single-family house. RANDLE advised that she left the house at approximately 1000 hours, on 07/01/2008. She returned at approximately 2130 hours. As she pulled into the driveway, RANDLE observed that a bicycle belonging to her daughter, OIV/ was lying in the driveway in front of the unattached garage behind the house. RANDLE explained that the door to the garage is broken, and as such is permanently open.</p> <p>As she went to replace the bicycle inside the garage, where it is normally stored, RANDLE observed that a bicycle belonging to her other daughter, OIV, was missing from inside the garage. Also missing was a cardboard box, as were numerous tools and bottles of automotive fluids stored inside the box.</p> <p>RANDLE went inside the house. All of the doors and windows remained locked, just as she left them earlier that same day. RANDLE noticed, however, that the screen to the first floor window on the north side of the house was half open. The window, however, remained locked and closed.</p> <p>RANDLE advised that nothing appeared to be disturbed or missing from inside the house. It thus does not appear entry was gained.</p> <p>RANDLE has no suspects in this matter, but desires prosecution in the event one is identified. RANDLE was advised regarding solvability.</p> <p>Inv. Register processed the scene for evidentiary purposes, with negative results.</p> <p>I spoke to residents at 2034, 2044, and 2052 Warren Rd., but nobody at those addresses saw or heard anything.</p>
