Topic Original Report

MO1: By knowingly causing serious physical harm to another by repeatedly punching and kicking him, using closed fists and their feet.

MO2: By knowingly causing physical harm to another by pushing, punching, and pulling the victim to the ground.

MO3: By being voluntarily intoxicated and creating a risk of harm to themselves, others and/or others property.

On 07/04/08 at 0256 hrs., cars were sent Code 3 to the area of Detroit and Westwood for a fight in the middle of the street with several people on top of another and beating him up. On arrival, officers found (VIC)RYAN DEMALINE on the west side of Westwood Ave., holding himself up with his arms and knees, and bleeding from the face. (ARA)DENNIS JACOBS, (ARA)TIMOTHY HACKNEY, and (ARA)LAUREN CARLSON were walking westbound on Detroit in front of the Armed Forces Recruiting Center, 15715 Detroit. Officers stopped the three as other officers tended to DEMALINE. Officers also spoke with (WIT)ROBERY HALAK, (WIT)CASIMIR WIECZOREK, (WIT)DANIELLE ZORNES, and (VIC)JENNIFER MILES.

JACOBS, who had a yellow shirt on, HACKNEY, who did not have a shirt on, and CARLSON, stated that while they were in the bar, a male later identified as DEMALINE, was making passes at CARLSON, HACKNEY's girlfriend. While the three were waiting outside for a cab, they stated that an argument ensued and DEMALINE began swinging at HACKNEY, trying to hit him. JACOBS states that he intervened and was knocked to the ground, receiving a road rash type injuries to his right hand and right knee. JACOBS states that while he was on the ground, ZORNES ran toward him. He said that he brushed her aside to avoid her attack, knocking her to the ground. He said that ZORNES was the one who was attacking DEMALINE and that he, HACKNEY, and CARLSON were trying to stop it.

Paramedics arrived and transported DEMALINE to Lakewood Hospital. They advised that DEMALINE had a broken right ankle and a possible broken nose. Several witness statements were taken at the scene.

MILES stated that she was inside Bar 2 when a female came in and told her that her husband, DEMALINE, was in an argument with another male outside. She went outside to break it up when the two males, identified as JACOBS and HACKNEY, began going after DEMALINE. The male in a yellow shirt (JACOBS) punched her in the face then grabbed her hair and pulled her to the ground. She got up and ran back inside the bar. MILES stated that she does desire prosecution for Assault.

HALAK stated that he was in the rear parking lot of 15701 Detroit when he heard a loud commotion coming from the area of Westwood and Detroit. He drove from Rosewood, east on Detroit, and saw two white males beating up another male who was down on the ground on Westwood Ave. A male wearing a yellow shirt (JACOBS) and a male without a shirt (HACKNEY), were punching and kicking the male who was lying in the street. A female wearing a stripped shirt (MILES) came from the bar and tried to break up the fight and was tackled to the ground by HACKNEY. A female in a black tank top (CARLSON) also began kicking DEMALINE, twice in the chest and once in the face. JACOBS, HACKNEY, and CARLSON then began to walk west on Detroit when LPD arrived.

WIECZOREK states that an argument started when MILES got shoved by JACOBS. DEMALINE, who was intoxicated, approached JACOBS. JACOBS began to punch DEMALINE several times, refused to leave, and continued attacking DEMALINE. JACOBS went to push MILES again, but hit her in the face. DEMALINE retaliated toward JACOBS again, but was jumped by both JACOBS and HACKNEY, knocking DEMALINE to the ground. JACOBS and HACKNEY began to beat DEMALINE while he was down on the ground.

ZORNES stated that she was in the bar when a female came in and told MILES that her husband was involved in an argument. When she went outside, she saw a male in a yellow shirt (JACOBS), and a guy without a shirt (HACKNEY), beating up DEMALINE, who was on the ground. MILES was trying to break up the fight when she was punched in the face by JACOBS. ZORNES hit JACOBS in defense of MILES, at which time JACOBS, HACKNEY, and CARLSON left westbound on Detroit.

JACOBS, HACKNEY, and CARLSON were all arrested for Felonious Assault and Disorderly Conduct-Intoxication. JACOBS and HACKNEY were also charged with Assault. CARLSON was secured in handcuffs and transported to LPD by PTL HAYES. She was booked in by PTL ROMANELLO, PTL HAYES, and DISP MALLOY. JACOBS and HACKNEY were secured in handcuffs and transported to LPD by myself. JACOBS was booked in by PTL ROMANELLO and myself, at which time his yellow shirt was confiscated, tagged as evidence, and secured in locker #17 of the property room. HACKNEY was booked in by PTL ROMANELLO and PTL HAYES.

INV ALLEN responded to Lakewood Hospital to obtain photos of DEMALINE's injuries and to get a statement. INV ALLEN advised that due to DEMALINE's injuries and state of intoxication, DEMALINE was unable to provide a written statement, but did advise that he desires prosecution for Felonious Assault. He said he would respond to LPD to give a statement at a later date. He was being treated by Dr. Hastings, diagnosis not known at the time of the report.

JACOBS has a CCH showing FBI #851591CC5 and BCI #J022778, with one prior arrest/conviction for Felonious Assault. HACKNEY and CARLSON do not have a CCH.
