Topic Original Report

- M.O. By breaking into an unoccupied residence to take copper piping.
- M.O. By being in possession of several tools used to cut copper piping.
- M.O. By using the listed vehicle as transportation in the commission of a felony.

Sgt. Favre, sir,

On 07/06/2008 at 1212 hours, Ptl. Thibodeaux and I were detailed to 1610 Wyandotte on the report of a possible B&E in progress. COM/GILDA TIMIESKI advised dispatch she believed there were parties in the vacant single family home stealing the copper piping.

Prior to our arrival, Ptl. Piechowiak advised there was a party coming out of the south window of 1610 Wyandotte. Upon our arrival, Ptl. Piechowiak had one female and one male in handcuffs on the south side of the house. Ptl. Piechowiak advised us he observed the female coming out of the window and saw the male behind her. Ptl. Piechowiak stated he advised the female to continue to exit the house and placed her in handcuffs. Ptl. Piechowiak then advised the male to exit the window and placed him in handcuffs. The male was identified as ARA/ ERIC J. BRUNER. The female was identified as ARA/ MELISSA G. OLSEN. Ptl. Piechowiak located one pair of gloves in each cargo pocket of ERIC's shorts. Ptl. Piechowiak also found the metal cutters and clamp in ERIC's right cargo pocket of his shorts. ERIC also had a hat and headband flashlight that fell off when he exited the house. C.O. Gonzalez was on scene and found a pipe cutter in OLSEN's left rear pant pocket.

ERIC and OLSEN were placed under arrest and read their Miranda rights. OLSEN then advised Ptl. Thibodeaux that she only went to the house to look at it and did not know her fiance ERIC, was cutting copper pipe from the basement. ERIC was placed in the back seat of patrol car 217 and OLSEN in the back seat of patrol car 203.

Ptl. Pietch and I checked the exterior of the house and found it all secure except the south window where ERIC and OLSEN exited. I then climbed through the south window and checked the first floor of the house for any other occupants. I unlocked the side door for Ptl. Thibodeaux and Ptl. Pietch who checked the remainder of the house with me. We found a neatly stacked pile of copper piping cut into approximately 24 inch sections in the basement. It appeared to be approximately 60 feet of copper piping. At this time Inv. Malloy arrived on scene. Inv. Malloy photographed the pile of copper piping and processed the scene. The house was unable to be completely secured due to the broken south window.

I spoke with OIV/ STEVEN M. GORBACH FOSTER who resides at 1593 Wyandotte Ave. GORBACH FOSTER advised he was walking home from the auto parts store and as he passed 1610 Wyandotte he could hear noise coming from the house. GORBACH FOSTER stated it sounded like someone was ripping piping out of the basement. GORBACH FOSTER stated he then went to his friend TIEMSKI's house at 1606 Wyandotte and asked her to listen to the noise in the house. GORBACH FOSTER stated they both heard the noise and TIEMSKI called LPD.

Ptl. Piechowiak advised ERIC stated he was driving a Mercury Sable. The surrounding area was checked for possible vehicles. Ptl. Pietch found a 2004 green Mercury Sable (EDG9407) parked in front of 1667 Wyandotte Ave. that listed back to ERIC's mother, OWN/ THERESA J. BRUNER. Ptl.

Piechowiak advised ERIC had the keys for the vehicle. The keys were used to gain access to the inside of the vehicle. The vehicle was inventoried prior to tow by Ptl. Pietch. An eight inch piece of 1/2 inch copper piping and a clarinet was found in the trunk. The vehicle was towed by Kufner's Towing and held for the owner. Both items were tagged and secured in the property room.

Ptl. Thibodeaux and I transported OLSEN to LPD. OLSEN was booked into jail by Ptl. Thibodeaux, C.O. Bunner, and Dispatcher Kappa. Ptl. Piechowiak transported Bruner to LPD. ERIC was booked into jail by Ptl. Thibodeaux and C.O. Bunner. All evidence was secured in the property room. In ERIC's property, two metal scrap metal ID cards were found issued by West Side Metals Corp and Scrap Mart. OLSEN was also found to have a scrap metal ID card issued by Scrap Mart. All scrap metal ID cards were tagged and secured in the property room. VIC/ REALTYWISE was advised of the situation. ERIC has a criminal history for one prior drug arrest, BCI #C210725. OLSEN has no criminal history.
