Topic Original Report

MO: By inflicting and threatening to inflict physical harm while attempting to take victims bicycles.

MO: By giving a false name and date of birth in an attempt to conceal his identity.

On 7/6/08, at 2036 Hrs., I was on patrol at Lakewood park. A female flagged me down and advised me that she witnessed three black juveniles attempt to forcibly steal three other juveniles bikes. She pointed out the males walking in the park. The males observed me speaking with her and began to quickly walk away from my location. I approached the three males and ordered them to stop and speak with me. They complied with my order.

I advised them the reason for the stop. They Identified themselves as _____, _____, and _____. All three denied attempting to steal anyones bike. At this time no one had called LPD regarding this incident. The three males were advised and released. The three males were later correctly identified as ARJ/_____, ARJ/_____, and ARJ/_____.

At 2100 Hrs, dispatch detailed PO GAMPFER to 1301 Jackson on call from COM/EVA advising her son and his friends were "jumped" by three black males. PO GAMPFER spoke to VIC/_____, VIC/_____, and VIC/_____. In speaking with the victims PO GAMPFER advised me that the description of the suspects matched the three males I was out with at Lakerwood park.

While I was in route to PO GAMPFER'S location I observed _____, _____, and _____ walking E/B on Clifton. I stopped them at Clifton and Elbur. I advised them the reason for the stop. PO GAMPFER brought _____, _____, and _____ to my location. All three victims positively identified _____ and _____ as the males who assaulted them and attempted to steal their bikes.

I advised _____, _____, and _____ they were under arrest for Robbery. They were read their Miranda rights and secured in the back of unit #203. _____, _____, and _____ were transported to LPD jail and booked in by myself and CO MCCARTHY for Robbery and Giving false information.

_____ and _____ advised the following. They were riding their bikes to _____'S house from Burger King on Detroit. They got to the intersection of Belle and Detroit and _____, _____, and _____ ran towards them and grabbed the handle bars of _____'S and _____'S bikes. _____ was ahead of them and got away. _____ and _____ told them to get off the bikes or we will start hitting you. _____ and _____ complied. They threw _____ bike to the ground and took _____'S bike across the street to Aladdins on Detroit. _____ left to find help. _____ attempted to call LPD on his cell phone. _____ and _____ again approached _____ and asked him who he called and to give them the phone. _____ refused to give them the phone. They told _____ they would give him his bike back. _____ followed _____ and _____ to the alley next to Aladdins. _____ began to ride the bike in circles in the alley. _____ asked him for the bike and _____ picked it up and threw it at him striking him in the legs. _____ stated he attempted to pick up the bike and _____ punched him in the jaw and
