Topic Original Report

M.O. By striking the victim in the mouth with her fist, causing the victim physical harm.
M.O. By being voluntarily intoxicated creating a risk of harm to herself or others.

On 7-7-08, I was detailed to 11720 Edgewater regarding a female who jumped into the pool naked, assaulted a female, then got into a vehicle heading towards W.117th. Dispatch advised the vehicle left the city heading east. SGT.ESCHWEILER was able to locate the vehicle at W.115th and Clifton. I arrived to assist. We spoke to the driver OIV/ROBERT PELAREZ and ARA/SHARON LEMON-TOMATZ, and learned the following.

TOMATZ stated that she was at the pool at 11720 Edgewater. TOMATZ stated that she took her top off and shorts, and jumped into the pool. While she was in the pool, TOMATZ stated she was asked to put her clothes on and get out of the pool. TOMATZ stated she put her clothes on and left the pool area. TOMATZ stated she gathered her belongings and left the pool area without incident. TOMATZ stated she got picked up by a friend and left the apartment complex. While Officers were speaking with TOMATZ, we detected a moderate odor of an alcoholic beverage on her breath. TOMATZ also had bloodshot glassy eyes and a slow slurred speech.

P.O. PERHACS was at 11720 Edgewater speaking to the other party. P.O. PERHACS spoke with VIC/SAMUELLE WHITLEY, who advised the following. WHITLEY stated she was sitting by the pool when another resident named OIV/VICKI and TOMATZ arrived at the pool. WHITLEY stated she looked over at the pool and saw TOMATZ completely nude by the pool fence. WHITLEY stated she told TOMATZ you can't be in the pool naked. WHITLEY stated TOMATZ approached her and punched her in the mouth with her right fist. WHITLEY stated she fell to the ground and told someone to call the police. I could not locate any information in the computer for VICKI. P.O. PERHACS advised that WHITLEY had a split lower left lip. The cut was about 1/2 inch and was bleeding slightly. WHITLEY advised she did not need medical attention. INV.PICKENS took photos of WHITLEY'S injuries.

P.O. PERHACS also spoke to WIT/JENNA GAUNTNER, who stated she saw the incident happen. GAUNTNER stated she also asked TOMATZ to leave the pool and put some clothes on. GAUNTNER stated she saw TOMATZ gather her belongings and looked like she was leaving the pool area. GAUNTNER stated that TOMATZ walked over to WHITLEY and punched her in the mouth, then left the apartment complex. P.O. PERHACS was able to obtain statements from WHITLEY and GAUNTNER.

P.O. PERHACS advised myself and SGT.ESCHWEILER of the statements he was obtaining at 11720 Edgewater. Per SGT.ESCHWEILER, TOMATZ was placed under arrest for Assault and DCI and secured in car #217. I transported TOMATZ to the station, where she was booked in by myself, Disp. Dibacco, and C.O. McCarthy. TOMATZ was issued citation #M41026 for DCI and #M40725 for Assault.
