Original Report

On 7-7-08 at 2314 hours, COM/ANTHONY WYLIE came to the front counter to report that SUB/JEFFREY FROUDE slapped his chest and grabbed his shirt. WYLIE explained that FROUDE is his daughter's guardian ad litem. WYLIE explained that on 7-7-08 at approx. 2120 hours he was walking EB on Detroit in the area of Granger when he walked around a male and female that were in front of him. WYLIE indicated that he identified the male as FROUDE. WYLIE advised that he wanted to talk with FROUDE about an e-mail he had received from him. WYLIE advised that FROUDE became agitated because he thought that he was being recorded. WYLIE stated that FROUDE slapped his chest and grabbed his shirt.

WYLIE insisted that he was assaulted and that FROUDE was not allowed to grab his shirt. He advised that he wanted the incident investigated and desired prosecution. WYLIE advised that he was not injured. WYLIE provided a written statement.

I located FROUDE's information by super name search. FROUDE did not answer when I tried to contact him.

At approx 9:20pm I was walking from Rocky River Library to visit a relative in Lakewood as I crossed the street near St. James Church there were two people near the antique store a woman and a man.

I attempted to walk around the couple as I was doing so I recognized the male as Jeffrey Froude an attorney assigned to represent my daughter in a juvenile court matter.

He had recently e-mailed me which I had just printed at Rocky River Library. I said "Hello" "I didn't realize that was you" "I just got your e-mail."

I reached in my pocket to show him. He snatched it out of my hands. Girl said "What's this?" The piece proceeded to slap me in the chest and grab my shirt and said "Are you recording me?" "Are you recording me?" (loudly) "Your attorney told me you are recording me." To which I said "if that is the case that is a violation of attorney client privilege" To which he denied and backpedaled.

I was not expecting number one to see him, then number two his behavior towards me.

He attempted to bait me into a nasty verbal exchange. I tried to refocus the conversation to the e-mail and arranging a time he could visit my apartment. Further I asked him to please correct a matter in the previous O.A.L.

report. He said he had verified this matter by interviewing three people. To which he said further "Do you want to discuss it?" (Yelling) I said to him "You are obviously upset (agitated) and I don't feel comfortable speaking further with you without a witness." To which he said "Oh you need a witness." I said it is not appropriate for you to be discussing this here and I will put everything in writing. The woman he was with also told "It's not appropriate for you to be discussing it here."

Mr. Froude began yelling "Don't you ever walk up behind me!"

I explained to him I did not walk up behind him, but attempted to walk around him.

He continued to yell "Don't you ever walk up behind me!"

I explained to it was a public sidewalk and asked him to please look at me to convey to him that I was telling the truth that it was happenstance that I ran into him and that I did not walk up behind him, but attempted to walk around him and pointed to the sidewalk which was wide enough to accommodate three people. He continued screaming. I walked away. I spoke with a family member who advised me to follow up with a police report documenting the matter.
