Topic Original Report

- MO- By having in the vehicle they were operating/a passenger in, barricade ends and traffic cones belonging to the city of Lakewood, and not having consent to possess same
- MO- By having a glass drug pipe with burnt residue in his vehicle, by having 2 packs of rolling papers in his wallet as well as marijuana in a folded paper
- MO- By being 17 years of age and out on the streets of Lakewood between 2300-0600hrs
- MO- By being 17 years of age and in possession of 3 cigars and an open pack of cigarettes

On 07/07/2008 at approximately 0120hrs, I was Southbound on LEWIS approaching ATHENS on motorcycle 292. A silver Dodge Caravan was traveling Westbound, and stopped for the stop sign before I came to a stop. I stopped and the vehicle continued to sit at the stop sign. The passenger then motioned for me to go. I remained stopped and the vehicle began traveling Westbound. As it passed and I started to move, my headlight illuminated the rear interior of the van, and I saw what I believed may be a reflective traffic cone inside the van. I proceeded Southbound up to LAKEWOOD HTS. and then Westbound to BUNTS. I turned Northbound on BUNTS, then West on ATHENS. I caught up to the vehicle on ATHENS at ARTHUR.

The vehicle turned Northbound onto ARTHUR, and drove left of center from ATHENS to MADISON. There were parked cars along the East curb, but the vehicle was traveling further away from them than necessary. The vehicle stopped across the crosswalk at ARTHUR and MADISON. It turned Westbound onto MADISON, and I initiated a traffic stop at MADISON and LAKELAND.

I approached the vehicle and observed numerous traffic cones and barricade ends in the rear of the van. The driver produced his OL and was identified as (ARJ). He was informed of the reasons for the stop. (ARJ) said, "I was just creeping up" when told of the stop sign violation. I told him that I suspected the cones and barricades were stolen, and he had one chance to be truthful about where he obtained them. He told me that he got them from friends in WESTLAKE.

I had (ARJ) step out of the vehicle so I could speak to him away from the other 2 occupants. He was found to be 17yrs of age, and thus was placed under arrest for Curfew. I asked (ARJ) if he had any drugs or weapons on his person, and he admitted to having marijuana in his left front shorts pocket. I retrieved an envelope containing marijuana from that pocket. I located 2 cigars in plastic tubes in his right pocket.

PTL. GAMPFER and PTL. DENNIS MCCARTHY arrived to assist. The front passenger was identified as (ARA)PETERS. PETERS was directed out of the van. The rear passenger was identified as (SUB)FEARON. FEARON was found to have 2 Contempt of Court warrants out of our department.

FEARON granted PTL. GAMPFER consent to search his person. In his wallet, 2 packs of rolling papers and some marijuana in a folded white paper were located. He was secured and advised he was under arrest for Drug Paraphernalia.

I informed all 3 males of their Miranda Rights and they acknowledged their understanding of them. (ARJ) maintained that he got the traffic barricades and cones from friends in WESTLAKE. He would not identify them or where they lived specifically. PETERS said that he and (ARJ) stole the barricades off lawns on LAKE about a week ago. He believed the cones came from a

driveway/sidewalk repair on LARCHMONT or FRIES. FEARON was picked up on WATERBURY just moments before I initially saw the van, so it was determined he had no knowledge of the barricades and cones.

PTL. GAMPFER conducted an inventory of the van prior to tow. She located a glass multi-colored drug pipe, an open pack of cigarettes, and a cigar in a plastic container on the front floor between the driver's and passenger's seats. All 3 males denied ownership of the pipe. was advised he was being charged with Drug Paraphernalia. In viewing the interior rear of the van, officers discovered that there were white wooden barricade ends which had "LKWD" painted on them. I was able to readily identify the markings as those used by the Public Works Department of (VIC)CITY OF LAKEWOOD. Photos were taken of the barricades and cones. and PETERS were advised of the Receiving Stolen Property charge.

The drugs and paraphernalia were collected and placed in car 214. The barricades and cones were placed in 227 upon SGT. GANNON's arrival. He transported them to the LPD secured property room and tagged them.

was secured in car 213, and transported to the back hill of LPD by PTL. DENNIS MCCARTHY. PETERS and FEARON were secured in car 214, and transported to LPD by PTL. GAMPFER.

The van was towed to Kufner Towing to be held for father, (OWN)JAMES E. HUGHES.

was issued Citation #D1162932 for Operation of Vehicles at Stop Signs and Tobacco Use By Children. He was advised of the RSP, Drug Paraphernalia, and Curfew charges. He was released to his father on the back hill of LPD. They were informed of the court date.

FEARON was booked in by PTL. MISCH and me. PETERS was then booked in by PTL. MISCH and me. He was issued Citation #M41065 for Drug Paraphernalia, and #M41066 for RSP. He was advised of his court date.

The marijuana was weighed separately and tagged. The paraphernalia was tagged separately. The drugs and paraphernalia were then placed down the drug chute. The cigars and cigarettes were tagged and placed in locker #20 of the property room.
