Topic Original Report

M.O./1: By pointing a shotgun at the VIC and stating he was going to kill him.

M.O./2: By striking the VIC in the head with a closed fist.

Sgt. Kauchek, sir:

On 7/8/2008 at 0244 hours, officers were dispatched to the bus stop on Detroit at Belle on a call from COM/ELLEN ADKINS stating parties were leaving the area in a vehicle and one occupant had a shotgun. ELLEN described the vehicle as a red four door automobile, possibly a Pontiac. Officers checked the area for the vehicle with negative results.

ELLEN and her boyfriend, VIC/MICHAEL GROSSMAN, were at the bus stop on Detroit at Belle. ELLEN stated that her son, ARA/JOSHUA ADKINS had threatened GROSSMAN with a shotgun at JOSHUA's apartment at 1379 Belle. JOSHUA was accompanied by his girlfriend, OIV/ROXANNE DALEY, and an unknown B/M.

ELLEN further stated the vehicle belonged to ROXANNE's father, OWN/MICHAEL DALEY. Officers learned that MICHAEL DALEY of Brooklyn owns the listed maroon Chevrolet Lumina. PO Perhaps remembered observing this vehicle entering BP on Madison at Warren just prior to the call. The area was checked for the Lumina with negative results. BROOKLYN PD was notified of the incident.

ELLEN also stated ROXANNE's mother lives at 14702 Leonard. Officers checked this address for the vehicle with negative results.

BROOKLYN PD located the vehicle at the residence of MICHAEL DALEY at 6120 Northcliff. Sgt L. Wilkins and Sgt Eschweiler responded to 6120 Northcliff. JOSHUA was placed under arrest for Felonious Assault. The B/M was identified as ARA/ANTONIO FAULKNER and placed under arrest for Simple Assault. Also, the shotgun was recovered.

GROSSMAN stated the following: GROSSMAN was asleep in the back bedroom of Apt 4, 1379 Belle. He has been staying there for the last couple of days with his girlfriend, ELLEN. GROSSMAN heard the door bell and ELLEN went to buzz the front door to the apartment building and unlock the apartment door. JOSHUA came into the bedroom with a shotgun and pointed it at GROSSMAN, saying, "Get the fuck out. You better leave." GROSSMAN observed an unknown B/M in the apartment along with ROXANNE. GROSSMAN left the apartment with ELLEN. Once outside the building, the B/M punched GROSSMAN in the back of his head on the right side. JOSHUA, ROXANNE and the B/M left N/B on Belle in a small red vehicle. GROSSMAN and ELLEN walked to the bus stop on Detroit at Belle and ELLEN called for help.

ELLEN stated the following: ELLEN has been staying with her son JOSHUA since April. Tonight ELLEN was sleeping with GROSSMAN in the back bedroom when she heard the door bell ring repeatedly. ELLEN buzzed the front door to the apartment and then unlocked the apartment door. JOSHUA entered the apartment holding a shotgun and pushed his way past ELLEN, heading for the back bedroom. JOSHUA was followed by an unknown B/M. JOSHUA's girlfriend, ROXANNE, also entered the apartment. Upon reaching the back bedroom, JOSHUA "cocked" the shotgun two or three times

and turned on the bedroom light. JOSHUA pointed the shotgun at GROSSMAN and said, "Get the fuck out of my house. I'm going to kill you." ELLEN and GROSSMAN left the apartment. Upon reaching the sidewalk in front of the apartment building, the B/M struck GROSSMAN in the side of the head, causing him to fall down.

GROSSMAN had a red mark on the right side of his face and the right side of the back of his neck was red. GROSSMAN denied medical attention. Inv Fioritto photographed GROSSMAN's injuries:

The apartment was checked and nothing of value was located.

ELLEN and GROSSMAN provided written statements. GROSSMAN desires prosecution.
