Topic Original Report

MO; By walking into apartment, telling victim to give him some money, then slapping/punching victim in face and taking money out of victims left front pocket without permission to do so.

On 7-9-08 at 1620 hrs., I was detailed to 11849 Clifton #D247 to speak with a party who was assaulted. On arrival, I spoke with COM/DWIGHT LEWIS, who is the on site Case Manager. LEWIS said that VIC/ was assaulted earlier by another tenant in the Youth Reentry program there. Note, resides alone in his own apartment. LEWIS said he handles all problems first and then makes a decision to involve the police or not. LEWIS said is a ward of the State of Ohio. LEWIS said Children and Family Services placed in this program there.

said he was in his apartment when ARA/JOSEF DIXON walked through his front door that was unlocked. said he thought DIXON was his friend but now knows he is not. said that DIXON asked him to give him some money as DIXON told him he is always protecting him from getting into trouble at the apartment building.

said DIXON was acting strange, and told him he was not going to give him any money. said DIXON slapped him in the face while he was standing in the living/kitchen area. said he sat down on his bed, said DIXON walked over to him and punched him in the lip area. said he got up, he said DIXON went into his left front pocket and took his thirty dollars. said DIXON told him not to tell anyone about this incident or he would burn his home down. wants to prosecute DIXON for Robbery.

I had INV. MALLOY and PO OBROCK respond to the scene.

INV. MALLOY took a photo of injured lip. Note, lip was split but he did not want medical treatment. LEWIS said that did not need medical treatment too.

PO OBROCK, INV. MALLOY, LEWIS and I went to DIXON's apartment #D145. I advised DIXON he was under arrest for Robbery and placed him in handcuffs. I then placed him in my patrol car.

PO OBROCK and INV. MALLOY were at the scene getting a written statement from

I read DIXON his Miranda rights. DIXON said he was in apartment but said they were just talking about old times there. DIXON said he left after several minutes of talking with. DIXON said he did not touch and did not take his money. DIXON said he does not know how lip was cut.

I transported DIXON to LPD jail, he was booked by CO BUNNER and placed in a holding cell.
