M.O. By entering the victim's unlocked auto and going through same without permission to do so.

On 07/09/08, at 0338 hours, P.O. PERHACS, INV. FIORITTO, and I responded to a call from VIC/PAMELA M JARVELA stating that two males broke into her vehicle that was parked in her driveway. She described the males as being white and wearing dark shirts. They were last seen on foot in the area of Hilliard/Woodward. P.O. CANTLIN and P.O. RUSNAK assisted in checking the area.

P.O. PERHACS called out with PAMELA's sons, OIV/JASON C. JARVELA and OIV/JEFFREY A JARVELA, at Lakeland/Delaware. They were also checking the area for the males. They added that one of the males was tall with blond hair, had an athletic build, was wearing red mesh shorts, and a gray t-shirt. They could not provide a further description on the other male. They saw the males last running west on Margaret. P.O. RUSNAK spoke with an anonymous male who saw the males running on Margaret, but advised that one went northbound and the other southbound when they reached Woodward.

I responded to 2196 Northland and spoke with PAMELA who advised the following: At approximately 0330 hours, JASON was dropped off by a friend at the corner of Northland/Margaret. He was walking towards the side of the house when he noticed two males in his driveway. The male, with the red shorts, entered PAMELA's listed '02 Black Jeep LIC/DEK7799 through the driver's side door and was going through items in the vehicle. He yelled at the males so they left running westbound on Margaret. JASON ran into the house and advised PAMELA of the incident. She immediately contacted the police. JASON and JEFFREY got into JASON's vehicle and drove around the area in an attempt to find the males.

PAMELA advised that she parked her vehicle in the driveway earlier in the evening. She stated that she did not lock her driver's side door. The glove compartment and center column were gone through but nothing was missing. PAMELA had already placed everything back prior to our arrival. PAMELA advised that she desires prosecution.

INV FIORITTO responded to this officer's location. Latents could not be obtained due to the rainy weather conditions. Nothing of evidentiary value was found inside the vehicle.

We checked the immediate area for other vehicles that were possibly gone through. They all appeared to be intact. While checking for the males, dispatch advised that PAMELA called back. She advised that her sons thought they may have recognized the white male with the gray shirt and red mesh shorts. JASON and JEFFREY advised that the male's name is SUS/MARK A NOWAK. They know him from the neighborhood. Dispatch advised that NOWAK's last known address is 2165 Carabel. INV. FIORITTO and I responded there. The house was all quiet and dark. It did not appear as though anyone had recently entered or exited the house. We were unable to speak with anyone at the residence at this time.

NOWAK has a CCH with a few Theft and B & E convictions. (FBI/186457AC8, BCI/C130081 and LKWD Ident #18093)
