Topic Original Report

MO: By forcing his way into victims apartment and threatening to inflict physical harm.

On 7/10/08, at 0037 Hrs., Officers were detailed code three to 1179 Andrews #3 on a call from VIC/ TIFFANIE TIMKO stating a male broke into her apartment. On arrival TIMKO advised officers that the male in question (later identified as ARA/IRVING ORTIZ) was now in apartment #4.

I spoke with TIMKO and her boyfriend VIC/JEFFREY SEWOLICH and learned the following. TIMKO stated she was on her porch having a cigarette. She said at about 0025 Hrs she went inside to go to bed. TIMKO stated that SEWOLICH was asleep on the couch. TIMKO said she heard a knock on the door and a man yell "open the fucking door". TIMKO stated she began to unlock the locks to see who was at the door. She said before she could get all three locks unlocked ORTIZ forced the door opened and entered the apartment. TIMKO stated that ORTIZ began to threaten her and SEWOLICH. She said ORTIZ stated he was going to kick her and SEWOLICH'S ass. TIMKO told ORTIZ she was going to call LPD. TIMKO stated she kept trying to shut the door on ORTIZ but he kept pushing his way back in the apartment. She said she finally got the door shut and locked the top chain. TIMKO called LPD. SEWOLICH confirmed TIMKO'S version of the incident. TIMKO and SEWOLICH both stated they had never seen ORTIZ prior to the incident.

The door to TIMKO'S and SEWOLICH'S apartment had fresh damage. The door opens into the living room of the apartment. The dead bolt and the door frame were damaged. TIMKO'S sternum area had a red mark on it that she stated happened when ORTIZ forced the door open. INV. DEUCHER photos of the door and TIMKO'S injury. TIMKO stated she did not need medical attention.

ORTIZ was advised he was under arrest for Aggravated Burglary. He was secured in the back of unit #201 and transported to LPD. ORTIZ was read his Miranda rights and he stated he understood. ORTIZ stated he was at OIV/CAROLYN DUNCAN'S apartment to look at doing some work on her ceiling. DUNCAN resides across the hall from TIMKO and SEWOLICH in apartment #4. ORTIZ stated that SEWOLICH was pounding on DUNCAN'S door. He said that he and SEWOLICH exchanged words but he never entered TIMKO and SEWOLICH apartment. ORTIZ stated the argument started because SEWOLICH accused him of being a drug dealer. ORTIZ stated that he had never met TIMKO or SEWOLICH before. DUNCAN was not very cooperative only stating that ORTIZ "didn't do it". She said that she was friends with ORTIZ and confirmed he was there to look at some work her landlord wanted done. ORTIZ was booked in by PO MISCH for Aggravated Burglary. ORTIZ has a CCH FBI#403350KA1 and BCI#B284153.

TIMKO and SEWOLICH both stated they desired prosecution and TIMKO provided a written statement.
